**AN ORDINANCE**

**AUTHORIZING A PROFESSIONAL SERVICES CONTRACT WITH URBAN-15 GROUP TO PROVIDE CULTURALLY BASED MUSIC AND DANCE PERFORMANCES FOR OLDER ADULTS AT VARIOUS CITY SENIOR CENTERS FROM APRIL 1, 2024, TO MARCH 31, 2029, IN A TOTAL AMOUNT NOT TO EXCEED \$125,000.00. FUNDING FOR EACH FISCAL YEAR IS CONTINGENT UPON CITY COUNCIL APPROVAL OF THE ANNUAL BUDGETS AND FUNDS.**

**WHEREAS**, the City of San Antonio's Department of Human Services (DHS) operates 12 Comprehensive Senior Centers and 6 part-time senior center sites that offer programs to assist older adults aged 60 and over to lead healthy, active, and engaged lives; and

**WHEREAS**, a Request for Proposals (RFP) was released November 15, 2023, to provide dance and cultural arts at City senior centers (RFP 24-015, 6100017528), and the local business URBAN-15 GROUP was the selected respondent and recommended for approval by the evaluation committee; and

**WHEREAS**, URBAN-15 GROUP will promote group exercise and physical activity on a weekly basis, for a total of 178 classes per year at no cost to older adults; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The execution a Professional Services Contract with URBAN-15 GROUP to provide culturally-based music and dance performances at various City senior centers from April 1, 2024, to March 31, 2029, in a total amount not to exceed \$125,000.00, is approved. A copy of the contract in substantially final form is attached and incorporated here for all purposes as **Attachment I**.

**SECTION 2.** Funding in the amount of \$12,500.00 for this ordinance is available in Fund 11001000, Cost Center 3806020201 and General Ledger 5202020 as part of the Fiscal Year 2024 Adopted Budget approved by City Council.

**SECTION 3.** Additional funding in the amount of \$112,500.00 for this ordinance is contingent upon City Council approval of the Fiscal Year 2025 and subsequent years' budgets that fall within the contract length.

**SECTION 4.** Payment in the amount up to \$125,000.00 is authorized to URBAN-15 GROUP and should be encumbered with a purchase order.

**SECTION 5.** The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager’s designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 6.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
