# Solicitation Overview



The Public Works Department solicited Request for Qualifications (RFQ) for On-Call Storm Water Civil Engineering Services on City of San Antonio projects. These services are to provide timely completion of storm water capital projects. Projects may include preliminary and final design and/or construction documents, cost estimates, plan and/or reports, which discuss findings, engineering calculations, recommendations, and work product.

- Request for Qualifications (RFQ)

## Proposed Term

- 3 years with 2, 1-year options

## Estimated Value

- \$1.3 million per contract annually
- \$20 million total
