Lauren Chavez, Senior Planner, presented item and stated applicant has been amended from 57.881 acres to 51.881 acres. The 6 acres would not be eligible to receive incidental take coverage for Karst due to ground disturbance already had commenced in the area. Staff recommends approval as amended.

Tom Carter, Pape Dawson Engineers, stated they have been working closely with City and County staff and have received Storm Water approval from Bexar County along with numerous other approvals within their review process. He stated their contractor met with City Arborist and received approval and proceed to move forward with the clearing trees. A Biologist has visited the site to ensure there were no features that are visible. He stated he would like the 6-acre portion to be included as there has not been any cut or fill on the property other than tree removal and general soil disturbance on the property.

Jenny Blair, Blair Wildlife Consulting, stated they application that was received there was one solution cavity found within the overall site (57.881 acres). However, it was found not to be suitable habitat for species however the geological characteristics requirement necessary for Karst formation and potential Karst Invertebrates Habitat are presented within the site.

Committee Member Brach requested item be table for further discussion and review.

Tom Carter, Pape Dawson Engineers, stated he would request item move forward with amended acres of 51.881 acres.
