

**ORDINANCE 2022-01-27-0038**

**APPROVING A MEMORIAL STREET DESIGNATION ON A  
PORTION OF "WESTROCK DRIVE" TO "JENNIFER SUE  
DELGADO MEMORIAL WAY", AT A TOTAL COST OF \$1788.96.**

**WHEREAS**, the City of San Antonio Development Services Department staff received a Street Name Change application to designate a portion of "Westrock Drive" to "Jennifer Sue Delgado Memorial Way"; and

**WHEREAS**, staff began implementing this request through the street memorial designation process as required by Chapter 6 of the City Code; and

**WHEREAS**, staff conducted a technical review finding the change to conform to City Code requirements for street memorial designation; and

**WHEREAS**, staff forwarded the request to all City of San Antonio departments and outside agencies for review and no opposition was identified; and

**WHEREAS**, staff properly posted and mailed notice of this request to abutting property owners, and notice requirements for renaming of the street have been satisfied in accordance with Chapter 6 of the City Code; and

**WHEREAS**, all costs were paid by the applicant; and

**WHEREAS**, a public meeting held a public hearing on November 17, 2021, allowing all interested persons to be heard with no opposition; and

**WHEREAS**, the Planning Commission held a public hearing on December 15, 2021, allowing all interested persons to be heard, and recommended approval. **NOW THEREFORE**,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**


**SECTION 1.** "Westrock Drive" located in City Council District 6, between U.S. Hwy 90 West and Westoak Road, is hereby designated "Jennifer Sue Delgado Memorial Way". All memorial designation requirements of Chapter 6 of the City Code have been met. The location is more specifically depicted in Attachment 1. City staff is directed to provide appropriate signage to this effect.

**SECTION 2.** The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 3.** This Ordinance is effective immediately upon receipt of eight affirmative votes; otherwise, it is effective 10 days after passage.



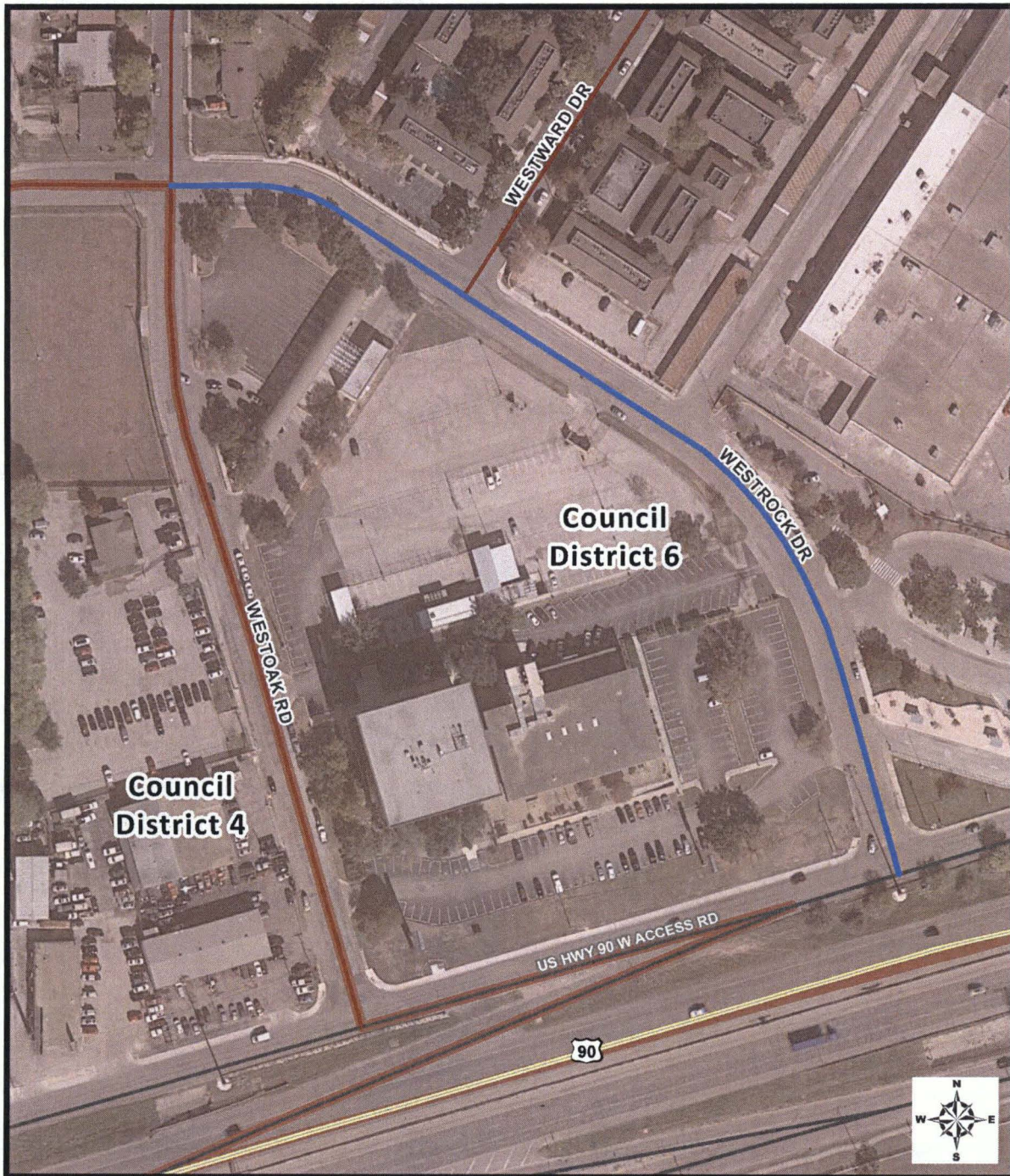
