APPROVING THE SUBMISSION OF A GRANT APPLICATION AND THE ACCEPTANCE OF FUNDS FOR THE FEDERAL AVIATION ADMINISTRATION (FAA) AIRPORT IMPROVEMENT PROGRAM FOR WEST APRON TAXILANE RECONSTRUCTION PROJECT AT THE SAN ANTONIO INTERNATIONAL AIRPORT IN THE TOTAL AMOUNT OF \$4,022,250.00 WITH THE FAA'S SHARE OF \$3,016,688.00 AND THE CITY'S SHARE OF \$1,005,562.00 FROM THE AIRPORT IMPROVEMENT AND CONTINGENCY FUND.

WHEREAS, the City regularly partners with the FAA for continued AIP grant funding for eligible projects at the Airport which is based on the Airport's preliminary submittal of its annual Airport Capital Improvement Plan (ACIP) to the FAA; and

WHEREAS, with this grant program, the Airport System can share costs with the FAA on large and critical airfield projects at the San Antonio International Airport which provides funding of up to 75% of eligible project costs with the City providing the remaining matching share; and

WHEREAS, in March 2022, the FAA indicated that the West Apron Taxilane project, a potential project for the FY 2023 – FY 2028 CIP, would be in consideration for FY 2022 End-Of-Year Funding and encouraged the City to include the project in its FY 2022 grant application; and

WHEREAS, it is now necessary to submit a grant application and accept funds for the West Apron Taxilane project in the total amount of \$4,022,250.00 with the FAA's share of \$3,016,688.00 and the City's share of \$1,005,562.00 from the Airport Improvement and Contingency Fund; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. This ordinance authorizes the City Manager or designee or the Director of Aviation Department or designee to submit a grant application and accept grant funds for Federal Aviation Administration (FAA) Airport Improvements Program (AIP) grants for a new project, the West Apron Taxilane project in the amount of \$3,016,688. This action will appropriate \$1,005,562 from the Airport Improvement and Contingency Fund for the City's 25% match and amend the FY 2022 – 2027 Capital Improvement Budget (CIP) to create the new project and establish its budget of \$4,022,250.00 in FY 2022.

SECTION 2. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost

Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 3. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
