

ORDINANCE 2022-05-05-0303

APPROVING AN EXTENSION FOR ONE YEAR THE
DOCKLESS VEHICLE PERMIT AND REVENUE
AGREEMENT WITH BIRD RIDES, INC. AND RAZOR USA,
LLC.

WHEREAS, pursuant to Ordinance No. 2019-12-12-1029, passed and approved December 12, 2019, City Council authorized the negotiation and execution of permit and revenue agreements for the exclusive right to deploy and operate Dockless Vehicles on City streets; and

WHEREAS, the City reached agreements with Bird Rides, Inc. and Razor USA LLC, effective January 12, 2020; and

WHEREAS, the Ordinance No. 2019-12-12-1029 provided for a two-year term and a one-year extension; and

WHEREAS, the City desires to extend this agreement for one year, to expire on January 12, 2023; and

WHEREAS, the City Council, upon consideration of and deliberations on such recommendation, desires to accept City Staff's recommendation; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council approves the terms and conditions of the Extension of Dockless Vehicle Permit and Revenue Agreement for a period of one year, to expire on January 12, 2023;


SECTION 2. The City Manager or designee is hereby authorized to execute the Extension to Dockless Vehicle Permit and Revenue Agreement that is substantively similar to the agreement that is attached hereto and incorporated herein for all purposes as **Exhibit A**.

SECTION 3. Funds received for this ordinance for vehicle permit fees will be deposited in Fund 11001000, Internal Order 219000000000 and General Ledger 4202966.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 5. This ordinance shall be effective immediately upon passage by eight affirmative votes; otherwise it shall be effective on the tenth day after passage hereof.



**EXTENSION TO DOCKLESS VEHICLE PERMIT AND REVENUE AGREEMENT
BY AND BETWEEN THE CITY OF SAN ANTONIO, TEXAS
AND _____**

This contract is entered into by and between the City of San Antonio, Texas, a home-rule municipal corporation ("CITY"), and _____.

I. TERM

- 1.1 The original agreement for a period of two-years pursuant to Ordinance No. 2019-12-12-1029 became effective on January 12, 2020 and expired on January 12, 2022.
- 1.2 Section 1, Term of the original agreement is hereby amended:
- a. "This Permit shall expire on the 12th day of January, 2022, and may be renewed for one additional year at City's discretion." is deleted, and
 - b. "This permit shall expire on the 12th day of January, 2023." is hereby substituted in its place.

II. CONDITIONS OF ORIGINAL AGREEMENT REMAIN IN EFFECT

- 2.1 The terms and conditions of the original contract between parties and City pursuant to Ordinance No. 2019-12-12-1029 shall be incorporated herein for all purposes, and shall remain in full force and effect during the term of this extension to the original contract.
