Briefing and Possible Action on the following items

1. Interview of applicants for full and part-time Municipal Court Judges. [Carla Obledo, Municipal Court]

Chair Cabello Havrda announced that the final candidates for Municipal Court Judge would be interviewed and the appointments for full-time and part-time Judges would be discussed. She reported that there were currently nine full-time Judges and six part-time Judges and the Committee would seek to fill additional positions to bring the number of full-time Judges to 10 and the number of part-time Judges to nine.

Chair Cabello Havrda stated that during the interview process, the Committee would seek to establish that applicants met the statutory and City Charter qualifications for Municipal Court Judge. She indicated that the terms for all current Municipal Court Judges would expire on April 30, 2022 and they would serve in a holdover capacity until the appointments were brought before the City Council for consideration. She stated that the terms of the new Municipal Court Judges would commence on May 1, 2022.
