

SUBJECT:

Reappointment of the current Trustees of the North Sector and the Southeast Quadrant of the San Antonio Water System (SAWS) Board of Trustees.

SUMMARY:

The Governance Council Committee will interview the two current Trustees appointed to the North Sector and the Southeast Quadrant of the San Antonio Water System Board of Trustees to consider their reappointments as they have remained in holdover status since May 31, 2022.

BACKGROUND INFORMATION:

On April 30, 1992, the City Council created the San Antonio Water System by Ordinance 75686. Section 32 of this Ordinance prescribes management of the System by a Board of Trustees, which includes the Mayor as an ex-officio member. Paragraph D provides that all vacancies on the board shall be filed by a majority vote of all members of the City Council then holding office.

The San Antonio Water System Board of Trustees is vested with the complete management, control and operation of the Water System. The Board controls the expenditure and application of the revenues of the System and makes recommendations to the City Council concerning rates, fees, and changes for services rendered by the System. Members serve a 4-year term of office, beginning on June 1 and ending on May 31, and are limited to serving 2 terms of office, unless their first appointment was for the remainder of an unexpired term of office of less than two years.

Paragraph 4 of Ordinance No. 87010, passed on November 20, 1997, requires trustees to be U.S. citizens and reside inside the corporate limits of the City or inside the area served by the System. The Mayor is authorized to appoint the Chair from current board members, with confirmation by the City Council, for a term of one year expiring May 31 of each year.

Currently, all of the At-Large seats are filled. Appointed At-Large Members include:

- Ed Belmares, Trustee, South Sector, term expiration: 5/31/2024
- Amy Hardberger, Assistant Secretary, Southwest Quadrant, term expiration: 5/31/2025
- Jelynne LeBlanc Jamison, Chairwoman, North Sector; term expired: 5/31/2022, in holdover status
- David McGee, Vice Chairman, Northeast Quadrant, term expiration: 5/31/2025
- Eduardo Jose Parra, Secretary, Northwest Quadrant, term expiration: 5/31/2025
- Marilu Reyna, Trustee, Southeast Quadrant, term expired: 5/31/2022, in holdover status

On October 21, 2021, Marilu Reyna was appointed as Trustee for the Southeast Quadrant for the remainder of an unexpired term of office ending May 31, 2022. Ms. Reyna is now seeking reappointment for a term to expire on May 31, 2026.

On August 6, 2020, Jelynne LeBlanc Jamison was appointed as Trustee for the North Sector for the remainder of a four-year term of office expiring May 31, 2022. Ms. LeBlanc Jamison is now seeking reappointment for a term to expire on May 31, 2026.

ISSUE:

Consideration and recommendation of reappointments of the current Trustees for the North Sector and Southeast Quadrants.

FISCAL IMPACT:

There is no fiscal impact.

RECOMMENDATION:

The recommendations of the Governance Committee will be presented to the full City Council for approval at a future A Session meeting.



JELYNNE LEBLANC JAMISON BIO



Jelynne LeBlanc Jamison is the President and Chief Executive Officer of The Center for Health Care Services (CHCS), the mental health authority for Bexar County. Opened in 1966, CHCS has an operating budget of \$129 million and over 1300 skilled and compassionate team members who help people find the solutions they need to live healthy and productive lives. CHCS works with children and families at 35 locations around Bexar County, providing them with the resources and support they need to make their life better. CHCS' mission is to share hope and support recovery with a full spectrum of innovative services that promote healing and help people live life to their full potential.

Jamison brings over 39 years of leadership experience with complex governmental organizations to the position. She previously served as the Executive Vice President and Chief Delivery Officer for CPS Energy, the largest municipally owned electric and gas provider in the nation, where she led a team of 1,853 employees and managed an operational budget of \$158 million and a capital budget of \$304 million. She led the organization with a customer-focused approach to service delivery and brought about technological, operational, and cultural enhancements. During her tenure with CPS, Burley served as the Acting General Manager and helped build public trust and stakeholder relationships, re-established a stable outlook with the bond rating agencies, and secured unanimous City Council approval for a new rate structure.

Prior to that, Jamison served as Deputy City Manager for Planning and Development with the City of San Antonio, with oversight for departments of Economic Development, Development Services, International Relations, Comprehensive Planning, Housing and Community Development, Public Works, Parks & Recreation, Code Compliance and the City Council Action Team. During her 24 years with the city, Jamison helped develop many economic and cultural development projects across the city, such as the development of the Alamodome, the 2001 expansion of the Henry B. Gonzalez Convention Center and the renovation of the Carver Community Cultural Center. Key economic development projects include Toyota Motor Manufacturing Plant, Rackspace Corporate Relocation,

Texas A&M University, San Antonio Campus and over half a billion in capital improvement projects across the City of San Antonio.

In addition to her public executive level leadership, Jamison is an Independent Director for NuStar Energy – a leader in the petroleum pipeline and terminal industry with terminal and storage facilities in the U.S., Canada, and Mexico.

Jamison is also actively involved with a wide range of professional and nonprofit organizations, including serving as Chairwoman for the San Antonio Water System, Trinity University Board of Trustees; CHRISTUS Santa Rosa Board of Directors; San Antonio Medical Foundation Board; Texas Public Radio Board of Directors; Girl Scouts of Southwest Texas, Vice President, Board of Directors; United Way of San Antonio Board of Directors; Masters Leadership Board of Directors; and is currently serving as the Past National President of the National Forum for Black Public Administrators.
