SUBJECT:

Consideration of At-Large Applicants to the Airport Advisory Commission (9 Slots)

SUMMARY:

The Transportation and Mobility Committee (TMC) will review and recommend applicants for 9 available seats to the Airport Advisory Commission (AAC). The AAC is comprised of 19 members appointed by City Council At-Large for staggered two-year terms. Chairwoman Melissa Cabello-Havrda appointed Councilman Mario Bravo and Councilman Clayton Perry to make recommendations for the 9 vacancies which will be considered during this meeting.

BACKGROUND INFORMATION:

The AAC is comprised of 19 members appointed by City Council At-Large for staggered two-year terms. The AAC is comprised of representatives from the following categories:

• Airport Business - Lessee

- Alamo Area Council of Governments (AACOG)
- Aviation Industry
- Business Community
- Community
- Federal Aviation Administration (FAA)
- Ground Transportation Industry
- Travel and Tourism Industry

The Transportation and Mobility Committee will review and recommend applicants for 9 available slots to the Airport Advisory Commission (AAC) including one representative from the Aviation Industry; two representatives from the Business Community; three representatives from the Community; one representative from the Federal Aviation Administration; one representative from the Ground Transportation Industry; and, one representative from the Travel and Tourism Industry.

The City issued a press release for the positions for the AAC in April 2022 which was posted on the social media sites for the City, San Antonio International Airport and Stinson Municipal Airport as well as TVSA. The Office of the City Clerk continuously accepts applications for all boards and commissions.
