FUNDING IN THE DONATED AMOUNT OF \$448,217.93 IS AVAILABLE FROM SAN ANTONIO LIBRARY FOUNDATION (SAPLF) AND \$510,179.79 IS AVAILABLE FROM THE 2017 - 2022 GENERAL OBLIGATION BOND PROGRAM INCLUDED IN THE FY 2022 - FY 2027 CAPITAL IMPROVEMENT PROGRAM.

WHEREAS, On May 6, 2017, voters approved the 2017 Bond Program, which authorized \$700,000.00 for improvements to the overall appearance and functionality of the Texana Resource Center; and

WHEREAS, The San Antonio Public Library Foundation (SAPLF) is a 501 (c)(3) non-profit organization that supports enhancements which will strengthen library services to the community; and

WHEREAS, the Foundation is donating funding in the total amount of \$448,217.93 for improvements related to the Texana Resource Center, \$119,111.00 will be used for additional design services to complete the Master Plan and the remaining \$329,106.93 will be used towards the construction of the Master Plan improvements, associated with the Texana Resource Center project at the Central Library; and

WHEREAS, on October 5, 2017, through Ordinance No. 2017-10-05-0742 City Council approved a professional architectural design services agreement in an amount not to exceed \$66,209.10 payable to Marmon Mok Architecture to provide professional design services for the Texana Resource Center Master Plan (6th Floor of Central Library) Project; and

WHEREAS, the proposed first amendment, attached hereto as Attachment I, will increase the total contract capacity to provide additional design services to complete the Master Plan for the Texana Resource Center at the Central Library; and

WHEREAS, this task order utilizes the Job Order Contracting (JOC) approved through Ordinance 2022-02-17-0107 by City Council on February 17, 2022; and

WHEREAS, this task order will improve the Texana Resource Center, including interior renovations consisting of new furniture, carpet and painting, mechanical, electrical, plumbing, technology and security advancements; and

WHEREAS, of the ten contractors approved as part of the JOC, Belt Built Contracting, LLC was selected; and

WHEREAS, this contract will be awarded in compliance with the Small Business Economic Development Advocacy (SBEDA) Program, which the Goal Setting Committee set a 24% Minority/Women Business Enterprise (M/WBE) subcontracting goal and a 3% African American Business Enterprise subcontracting goal; and

WHEREAS, construction is anticipated to begin in July 2022 and is estimated to be completed by April 2023; and

WHEREAS, it is necessary to reallocate a total of \$448,217.93 from San Antonio Library Foundation donations into the Texana Resource Center Project and amends the FY 2022 to FY 2027 Capital Improvement Program; and

WHEREAS, this Ordinance approves an amendment in an amount not to exceed \$119,111.00 increasing the design services agreement amount to \$185,320.10 with Marmon Mok Architecture for additional design services to complete the Master Plan for the Texana Resource Center; approves a task order to a Job Order Contract with Belt Built Contracting, LLC in the amount of \$510,179.79 for the Texana Resource Center project located in the Central Library in Council District 1; approves reallocates a total of \$448,217.93 from San Antonio Library Foundation donations into the Texana Resource Center Project; and approved to amends the FY 2022 to FY 2027 Capital Improvement Program; NOW THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee or the Director of the Public Works Department or designee, is authorized to amend the design services agreement with Marmon Mok Architecture in an amount not to exceed \$119,111.00 for additional design services to complete the Master Plan for the Texana Resource Center; is authorized to approve a task order to a Job Order Contract with Belt Built Contracting, LLC in the amount of \$510,179.79 for the Texana Resource Center project; is authorized to reallocate a total of \$448,217.93 from San Antonio Library Foundation donations into the Texana Resource Center Project; and is authorized to amend the FY 2022 to FY 2027 Capital Improvement Program

SECTION 2. Funds in the amount of \$650,000.00 are authorized to be received from San Antonio Public Library Foundation (SAPLF) to SAP Fund 29804000 Library Donations.

SECTION 3. Funds in the amount of \$105,000.00 are authorized to be received from the estate of Hugh Haynes Jr. to SAP Fund 29804000 Library Donations.

SECTION 4. The amount of \$755,000.00 is appropriated in SAP Fund 29804000 Library Donations and transfer is approved in the amount of \$105,000.00 to Fund 45099000 General Obligation Capital Projects, Project 23-01720 Central Library, and in the amount of \$650,000.00 to Fund 45099000, Project 23-01728 Texana Resource Center.

SECTION 5. The budget in Project 23-01720 shall be adjusted by increasing WBS 23-01720-90-10-05 with GL 6101100 and WBS 23-01720-05-02-10 with GL 5201140 each by \$105,000.00

SECTION 6. The budget in Project 23-01728 shall be adjusted by increasing the WBS Elements with GL accounts by the amounts in the tables below each totaling \$650,000.00

Funding for this project is provided by GO Bonds and donations and is in the FY2022-FY2027 CIP Budget as amended above.

Payment is limited to the amounts budgeted in the Operating and/or Capital Budget funding sources identified. All expenditures will comply with approved operating and/or capital budgets for current and future fiscal years.

SECTION 9. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 10. This Ordinance is effective immediately upon its passage by eight or more affirmative votes; otherwise, it is effective on the tenth day after passage.

WHEREAS, this amendment increases the total contract capacity by an amount not to exceed \$119,111.00 to provide for the cost of the additional services for total contract amount of \$185,320.10; and

I am pleased to present this Additional Service Fee Proposal, as requested, for the San Antonio Public Library Foundation (SAPLF) funded scope associated with the 2017 – 2022 Bond Project for the renovation of the Central Library 6th Floor Texana Resource Center and Genealogy Research Center.

As you are aware, the 2017 – 2022 Bond Program allocated approximately \$700,000.00 (\$425,000.00 construction cost) for 6th Floor Renovation scope which has been targeted to staff work areas including the valuable documents vault. The SAPLF has agreed to supplement that funding through a fundraising campaign to expand the scope renovation to include public service facilities and enhancements including the following elements developed through programming sessions with Library Staff and SAPLF Stakeholders. Values have been assigned to each element as target values for estimated costs of construction or the sums attained to date via committed donations as noted.

The individual costs itemized listed are budgetary pending final design development. The total sum of all potential SAPLF Funded elements to be considered in the design for the 6th floor renovation is \$1,160,000. However, as you are aware, recent market cost impacts have significantly impacted these values and Belt Built Construction, the assigned Job Order Contractor has updated current cost values.

Accordingly, this proposal reflects project design and packaging along with bidding as one overall project with elements defined as bid alternates in the documents in lieu of multiple separate project packages. The library will then determine final scope items to be completed in the sequence allowed by available supplemental funding for the project.

Please note also that this proposal excludes renovation of the 6^{th} floor restrooms. That scope is currently not funded in the Bond Project or targeted for SAPLF funding.

This proposal incorporates the schematic design fee associated with developing the 6th floor design of SAPLF which has been developed to date through the Bond Project but which was excluded from that approved contract fee. We understand that the SAPLF has committed to funding that portion of the fee in recognition that this would provide necessary fundralsing campaign resources to support their efforts. We would request that our bond contract be modified to incorporate those funds should the SAPLF elect to not continue with proceeding with this project effort in recognition of their commitment to fund that portion of the work.

If accepted, we presume this work will be fully completed under the contract terms authorized by the contract in place for the bond scope of work.

Basic services for this scope will include the following primary consultant team members to support design efforts:

CNG Engineering: MEP and Fire Protection System Design.

Combs Consulting Group, Inc.: Technology, Security and AV System Design.

The design scope as noted by CNG anticipates that current base building systems are adequate to support the new space improvements.

The design scope as noted by Combs Consulting Group anticipates IT system scope that includes, basic structured cabling; required audio visual; access control pathways and cabling; video surveillance systems pathways and cabling. Devices and equipment for these systems will be provided by the city.

This proposal presumes design of all work elements as one project with bid alternates as required to separate work items as necessary for funding purposes. This work will be packaged with current funded
