ORDINANCE

APPROVING A CONTRACT WITH GOMEZ FLOOR COVERING, INC., TO PROVIDE FLOOR CARE MAINTENANCE SERVICES AT MULTIPLE LOCATIONS THROUGHOUT THE CITY FOR AN ESTIMATED COST OF \$80,000.00 ANNUALLY, TOTALING AN ESTIMATED \$400,000.00 OVER THE CONTRACT PERIOD, INCLUDING RENEWAL OPTIONS. FUNDING IS AVAILABLE FROM THE FY 2022 ADOPTED BUDGET. FUNDING FOR SUBSEQUENT YEARS IS CONTINGENT UPON CITY COUNCIL APPROVAL OF THE ANNUAL BUDGET.

WHEREAS, the City released a Request for Competitive Sealed Proposals (RFCSP) to provide to provide floor care maintenance services at multiple locations throughout the City for the Building and Equipment Services Department; and

WHEREAS, one proposal was received and evaluated; and

WHEREAS, staff recommends Gomez Floor Covering, Inc., for award of this contract based on the City's standard RFCSP evaluation process; and

WHEREAS, approval of this ordinance will authorize a contract beginning upon the effective September 1, 2022 and terminating on August 31, 2025, with the option for the City to renew for two additional, one-year periods for an estimated annual amount of \$80,000.00 annually, totaling an estimated \$400,000.00 over the entire contract period, including renewal options; and

WHEREAS, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The proposal submitted by Gomez Floor Covering, Inc., to provide floor care maintenance services at multiple locations throughout the City for the Building and Equipment Services Department for an estimated annual amount of \$80,000.00 annually is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. A copy of the RFCSP is attached hereto and incorporated herein for all purposes as **Exhibit I**.

SECTION 2. Funding for this ordinance in the amount of \$80,000.00 is available in Fund 76001000, Cost Center 3506010003 and General Ledger 5204050 as part of the Fiscal Year 2022 Adopted Budget approved by City Council. Additional funding is contingent upon City Council approval of the Fiscal Year 2023 and subsequent budgets that fall within the term of the contract.

SECTION 3. Payment is authorized to Gomez Floor Covering, Inc., and should be encumbered with a purchase order.

SECTION 4. The financial allocations in this ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

SECTION 5. This ordinance is effective immediately upon passage by eight or more affirmative votes; otherwise, it is effective on the tenth day after passage.
