ORDINANCE

**APPROVING A CONTRACT WITH DOGETT
FREIGHTLINER OF SOUTH TEXAS, LLC, TO PROVIDE
THE SOLID WASTE MANAGEMENT DEPARTMENT
WITH SIX REPLACEMENT REAR LOADING REFUSE
COLLECTION TRUCKS FOR A TOTAL COST OF
\$1,625,443.00. FUNDING IS AVAILABLE FROM THE FY
2022 EQUIPMENT RENEWAL AND REPLACEMENT
FUND BUDGET.**

WHEREAS, Doggett Freightliner of South Texas, LLC, submitted an offer to provide the City of San Antonio Solid Waste Management Department with six replacement rear loading refuse collection trucks for a total cost of \$1,625,443.00; and

WHEREAS, these rear load refuse collection trucks will be used for retrieving curbside refuse, recyclables, and organic materials from City residences; and

WHEREAS, the Texas Local Government Code indicates that competitive bidding is not required under section 252.022(a)(2), which provides for a procurement necessary to protect the public health or safety; and

WHEREAS, funding is available from the FY 2022 Equipment Renewal and Replacement Fund budget; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The offer submitted by Doggett Freightliner of South Texas, LLC, to provide the City of San Antonio Solid Waste Management Department with six replacement rear loading refuse collection trucks for a total cost of \$1,625,443.00 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation and contract are attached hereto and incorporated herein for all purposes as **Exhibit I**.

SECTION 2. Funding for this ordinance in the amount of \$1,625,443.00 is available in Fund 72001000, Cost Center 3503200001 and General Ledger 5709080 as part of the Fiscal Year 2023 Adopted Budget approved by City Council.

SECTION 3. Payment is authorized to Doggett Freightliner of South Texas, LLC, and should be encumbered with a purchase order.

SECTION 4. The financial allocations in this ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

SECTION 5. This ordinance is effective immediately upon passage by eight or more affirmative votes; otherwise, it is effective on the tenth day after passage.
