Ordinance adopting the \$26,392,967.44 FY 2023 Action Plan and Budget for the four federal grant programs funded by the U.S. Department of Housing and Urban Development (HUD) which include the Community Development Block Grant (CDBG), HOME Investment Partnerships Program (HOME), Emergency Solutions Grant (ESG), and Housing Opportunities for Persons with AIDS (HOPWA) Program; authorizing a staff complement of 49 positions; and authorizing contracts to execute program budgets. [Lori Houston, Assistant City Manager; Veronica Garcia, Interim Director, Neighborhood and Housing Services Department]

Veronica Gonzalez, Interim Assistant Director of the Neighborhood and Housing Services Department (NHSD) presented an overview of the FY 2023 HUD Action Plan for the four Grant Programs as well as the priorities for the FY2022-2026 Consolidated Plan. Gonzalez summarized the use of funds to preserve existing homes for low and moderate income homeowners, provide new affordable housing, prioritized serves for youth, people living with HIV/AIDS, homeless and first time homebuyers.

Gonzalez stated that CDBG funding had been lowered this year nationwide which resulted in an adjustment of the funding amounts for FY2023 from the previous FY2022 levels. Gonzalez provided the budgets for each of the grants and described the work that would be provided by the new staff that had been requested. Gonzalez provided the timeline and results of the public engagement and stated that the deadline required by HUD to submit the Action Plan was August 16, 2022.

Councilmember Perry recalled that the need was 40,000 affordable homes and asked for confirmation of the total need. Interim Director Veronica Garcia stated that the Strategic Housing Implementation Plan (SHIP) had a goal of providing 28,000 affordable units through the various funding source. Councilmember Perry requested the number of new affordable units that had been created over the past 10 years.

Councilmember Perry compared the cost of the different programs and the number of units that were planned to be achieved through the different programs noting that rehabilitation and reconstruction did not gain any new units and recommended increased funding for more new units.

Councilmember Perry stated that he would not support the Item.

Councilmember Rocha Garcia, Chair of the Planning and Community Development Committee, outlined the work of the Committee on this Item and the input received from the community focused on homeownership. She stated that the best housing stock was the homes already in existence and it was important to preserve that housing stock. Councilmember Rocha Garcia applauded the work of various partners and the City's ability to leverage other funds to support the SHIP.

Councilmember Castillo expressed her support for the Item as it provided a variety of types of support for housing to meet the needs of low-income residents. Councilmember Castillo was looking forward to proactive wrap-around services for participants.

Councilmember McKee-Rodriguez highlighted the partnership with Crosspoint and asked whether the increased funding for homeless outreach would benefit the Department of Human Services (DHS). DHS Director Melody Woosley stated that the outreach team in her department was funded by the General Fund. Woosley stated that the ESG would fund Social Work Interns for the outreach team and San Antonio Metropolitan Ministries (SAMM) outreach workers.

Councilmember McKee-Rodriguez noted an overall reduction in the Under One Roof Program and asked if there would be additional General Funds available to make up for the reduction. Garcia stated that the TIRZ was previously used for the Under One Roof Program but there were less funds available this year, however, there was enough funds for the applications that were already received. City Manager Walsh stated that there would be a discussion about the General Fund in next week's Proposed Budget.

Councilmember Viagran expressed her support for the Item and highlighted the various opportunities within the grant funding to support housing especially with leveraging through partnerships including Crosspoint.

Councilmember Pelaez asked about what happened on the minor repair and owner occupied program if the owner sold their home. Garcia explained that the program contained restrictive covenants to ensure that the City would get its money back if sold.

Councilmember Bravo noted that the only way to make sure a person's rent did not go up which was to become a homeowner and recommended high investment in homeownership programs.

Councilmember Courage asked staff to describe the Fair Housing Program and the Affordable Rental Housing Program. Gonzalez explained the programs and outcomes which included applicant advising through the Fair Housing Program and leveraging partnerships in the Affordable Rental Housing Program.

Councilmember Courage expressed concern that the costs of a rental unit were rising quickly due to inflation and that the going rate for one unit was \$200,000 and the City's contribution would be \$50,000 per unit under the Program.

Mayor Nirenberg closed the discussion by noting that the affordable housing crisis had been building for many years and noted that in 2017, the City started focusing on the crisis which culminated in the SHIP. Mayor Nirenberg commented that while it was important to create new affordable housing, keeping families in their homes by helping rehabilitate them was also critical. Mayor Nirenberg recommended that the City provide assistance with title clearance to ensure people could stay in their homes. He added that the programs all helped with the housing burden for individuals facing poverty.
