# ORDINANCE 2022-08-11-0585

AUTHORIZING THE ACCEPTANCE OF GRANT FUNDS IN AN AMOUNT UP TO \$208,000.00 FROM THE OFFICE OF THE GOVERNOR, PUBLIC SAFETY OFFICE, CRIMINAL JUSTICE DIVISION, FOR THE TK22-FY22 DNA TESTING GRANT PROGRAM FOR THE GRANT YEAR OF OCTOBER 1, 2021 TO SEPTEMBER 30, 2022.

WHEREAS, the Office of the Governor (OOG), Public Safety Office, Criminal Justice Division (CJD) for the Office of the Governor, has grant funds in an amount up to \$208,000.00 available to assist the San Antonio Police Department, by reimbursing the costs associated with DNA kits collected from sexual assault/sexual offense victims, suspects and evidence that was submitted to the Bexar County Criminal Investigation Laboratory for analysis and testing; and

WHEREAS, SAPD submitted the grant application on June 17, 2022 for kits and evidence submitted for testing from October 1, 2021 through September 30, 2022; and

WHEREAS, this grant does not require an in-kind or cash match; NOW THEREFORE:

### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The grant application is hereby ratified, and the Chief of Police for the City of San Antonio is the City's authorized official, and he is hereby authorized to apply for, accept, reject, alter, or terminate an application for grant funds in the amount up to \$208,000.00 from OOG, CJD for the Office of the Governor, Public Safety Office, Criminal Justice Division TK22-FY22 DNA Testing Grant Program for the grant period of October 1, 2021 to September 30, 2022.

**SECTION 2.** In the event of loss or misuse of CJD grant funds, the City Council will return all funds to the OOG, CJD.

**SECTION 3.** Upon acceptance of this award, new funds and internal order numbers will be created, upon which the award amount will be appropriated from the Office of the Governor. A final budget, which will include SAP Internal Orders and SAP GL Accounts, will be submitted by the SAPD upon award.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 5.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
