

ORDINANCE 2022-08-11-0587

**AUTHORIZING THE EXECUTION OF AN AMENDMENT TO THE SPORTS LICENSE AGREEMENT WITH NORTHSIDE SUBURBAN LITTLE LEAGUE, INC. TO EXERCISE A RENEWAL TERM OPTION OF FIVE (5) YEARS FOR THE OPERATION, MAINTENANCE AND IMPROVEMENTS AT DESIGNATED BASEBALL FIELDS AT O. P. SCHNABEL PARK LOCATED IN COUNCIL DISTRICT 7.**

**WHEREAS**, since 1984 Northside Suburban Little League, Inc. (the "League") has utilized the four (4) baseball fields at O. P. Schnabel Park to provide organized youth sports activities year round; and

**WHEREAS**, in the 2021 season, the League served over 500 area youth; and

**WHEREAS**, the current agreement expires on August 31, 2022, and consistent with previous agreements, the first renewal option of the Sports License Agreement is proposed to commence on September 1, 2022 and expire on August 31, 2027, with the option to exercise one (1) remaining five (5) year renewal; and

**WHEREAS**, in lieu of rent, the League shall continue to be responsible for programming, maintenance, and operations of the designated baseball fields, including electric utilities, at O. P. Schnabel Park as well as the construction of improvements at the league's sole expense; and

**WHEREAS**, in addition, the League will be permitted to operate concessions with proceeds benefitting their program and to offset the cost of maintenance, operations and improvements;  
**NOW THEREFORE:**


**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager or designee or the Director of the Parks and Recreation Department or designee is authorized to execute an Amendment to the Sports License Agreement with Northside Suburban Little League, Inc. for operation, maintenance, and improvements at designated baseball fields at O. P. Schnabel Park located in Council District 7 for a renewal term of five (5) years.

**SECTION 2.** The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 3.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


