Jack Finger spoke in opposition to the Item.

#### DISCUSSION:

Councilmember McKee-Rodriguez thanked the applicant for their outreach and neighborhood groups for their feedback. Councilmember McKee-Rodriguez commented that adding two more units brought the price point from \$400,000 to \$380,000 noting that this was not affordable to most of the people in Council District 2.

Mayor Nirenberg supported the work of the Zoning Commission but commented that there were 56 notices mailed with 11 returned in favor and 9 opposed. Assistant Director of Development Services Melissa Ramirez stated that the Dignowity Hill Neighborhood Association was in support and a group calling themselves Concerned Citizens of Dignowity Hill was opposed. Staff recommended denial due to the proposed development density. Mayor Nirenberg expressed concern that the housing goals might not be met but requested more information from the department.

Councilmember Castillo stated that often developers say that market rate housing was affordable when it was not so she supported the denial.
