### **3. Introduction of new TAB member Nicki Roberson**

Mr. Mery introduced Mr. Roberson as a new TAB member representing District 2.

### **4. Update on the TAB recommended changes to Chapter 33 and TAB Chairperson:**

Mr. Gilbert stated that Staff would be taking the proposed amendments to the Transportation and Mobility Committee scheduled for August 29, 2022.

Mr. Gonzales questioned why Chapter 33 was going to the Transportation and Mobility Committee, instead of the Public Safety Committee.

Deputy City Manager Maria Villagomez stated that she had discussed these recommendations with Councilwoman Havrda; she is the Chair of both the Public Safety Committee and the Transportation and Mobility Committee. They both felt that the Transportation and Mobility Committee would be the more appropriate committee to review the proposed changes. She also stated that once reviewed, and if recommended, they would go in front of the full City Council, the outcome would be the same.

Mr. Rodriguez asked why these proposed changes have taken so long to get to a City Council Committee.

Rick Riley, Assistant Director of the Police Department, explained the process of collecting all the information, continued dialogs, and several levels of reviews were done to ensure all recommendations were considered.

Mr. Garcia wanted to make sure that the TAB recommended change to the TAB Chairperson was also going to move forward.

Mr. Gilbert informed the TAB that the TAB Chairperson recommendation would also be presented to the Transportation and Mobility Committee.

Mr. Gilbert asked the TAB if they had any other recommendations to move forward. No TAB members had any items.

### **5. The requirements for a taxicab company to maintain a minimum of three permits to remain a taxicab company:**

Mr. Gonzales mentioned that the ordinance requires taxicab companies to maintain at least 3 taxicabs to be a company, and the owner/operators are required to 1 taxicab to be a company.

R. Gonzales made a motion to amend chapter 33 taxicab company requirement to have 3 permitted taxicabs to be a company to 2 permitted taxicabs to be a company; N. Roberson seconded the motion.
