**AN ORDINANCE**

**AUTHORIZING A FUNDING AGREEMENT WITH THE  
HARVARD KENNEDY SCHOOL TAUBMAN CENTER  
FOR STATE AND LOCAL GOVERNMENT FOR A ONE-  
YEAR PILOT FELLOWSHIP PROGRAM. THE  
HARVARD KENNEDY SCHOOL TAUBMAN CENTER  
IS CONTRIBUTING \$75,000 TO THE FELLOWSHIP  
AND THE CITY IS FUNDING \$25,000.**

**WHEREAS**, the City of San Antonio is a leader in municipal government with a track record for developing and participating in first of its kind programs such Pre-K 4 SA and SA: Ready to Work; and

**WHEREAS**, Harvard Kennedy School Taubman Center asked the Economic Development Department to participate as its first local municipality in a one-year pilot Fellowship program; and

**WHEREAS**, the Fellow will be responsible for interpreting, formulating, and implementing policies and procedures at the direction of the Department's leadership team to include budget and financial operations, development, implementation and oversight of economic development strategies, coordination and collaboration with community economic development partners, and development of policies and guidelines; and

**WHEREAS**, said Funding Agreement provides for a 1-year term to begin in Fall 2022; and

**WHEREAS**, The Harvard Kennedy School is contributing \$75,000 to the Fellowship; and

**WHEREAS**, the City is funding \$25,000 to the Fellowship; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager or designee is hereby authorized to execute a Funding Agreement with the Harvard Kennedy School Taubman Center for State and Local Government to fund \$75,000 to the fellowship program. The Funding Agreement shall be executed for a one (1) year term. A copy of the Funding Agreement, in substantially final form, is attached hereto as Exhibit A. The terms and conditions of said Agreement are hereby approved.

**SECTION 2.** Funds generated by this ordinance in the amount of \$75,000.00 will be deposited into Fund 11001000, Internal Order 216000000000, and General Ledger Account 4406775. Funds are authorized to be appropriated per the attached program budgets.

**SECTION 3.** Funding in the amount of \$100,000.00 for this ordinance is available in Fund

11001000, Cost Center 1602040001, and General Ledger 5101015 as part of the Fiscal Year 2022 budget.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 5.** This ordinance is effective immediately upon passage by eight affirmative votes; otherwise, it is effective on the tenth day after passage.
