

**ORDINANCE 2022-08-18-0609**

**APPROVING AND ADOPTING HARRY WURZBACH ROAD,  
MARBACH ROAD, AND WEST AVENUE AS THE REMAINING  
CORRIDORS FOR MULTI-MODAL PLANNING STUDIES FUNDED  
BY THE ALAMO AREA METROPOLITAN PLANNING  
ORGANIZATION (AAMPO) TRANSPORTATION IMPROVEMENT  
PROGRAM**

**WHEREAS**, in 2018 the Alamo Area Metropolitan Planning Organization (AAMPO) approved four, \$1,000,000.00 multi-modal transportation studies under Corridor Mobility Planning as a Local Agency Managed (LAM) project of the AAMPO 2019-2022 Transportation Improvement Program (TIP) funded by the Texas Department of Transportation; and

**WHEREAS**, the Corridor Mobility Planning project will provide for in-depth analysis and preliminary project development on four (4) multi-modal corridor transformations; and

**WHEREAS**, the Multi-Modal Planning Studies will provide design planning concepts to improve the multi-modal mobility and increase pedestrian and bicycle safety of the studied corridor segments;

**WHEREAS**, on May 13, 2022, and June 21, 2022, the Transportation Department presented the evaluation process and three proposed corridors for study to the Transportation and Mobility Committee who recommended approval for full City Council consideration of three roadway segments: Harry Wurzbach Road, Marbach Road, and West Avenue for multi-modal planning studies; **NOW THEREFORE:**


**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Council hereby approves and adopts Harry Wurzbach Road, Marbach Road, and West Avenue as the remaining corridors for multi-modal planning studies funded by the Alamo Area Metropolitan Planning Organization Transportation Improvement Program.

**SECTION 2.** The City Manager or designee, or the Director of the Transportation Department or designee, is authorized to pursue multi-modal planning studies for Harry Wurzbach Road, Marbach Road, and West Avenue.

**SECTION 3.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


