ORDINANCE

APPROVING A CONTRACT WITH SILSBEE FORD-LINCOLN-MERCURY, INC., DBA SILSBEE FORD INC., TO PURCHASE SEVEN POLICE RESPONDER TRUCKS FOR A TOTAL COST OF \$335,872.75. FUNDING FOR THE REPLACEMENT TRUCKS IS FROM THE FY 2022 EQUIPMENT RENEWAL AND REPLACEMENT FUND BUDGET.

WHEREAS, the Interlocal Cooperation Act (the "Act"), Chapter 791, Texas Government Code permits local governmental entities to enter into interlocal agreements for the performance of governmental functions, including administrative functions, such as purchasing, in order to promote efficiencies and effectiveness; and

WHEREAS, the Region VIII Education Service Center ("Region VIII") is the Texas administrator of a cooperative purchasing program known as The Interlocal Purchasing System ("TIPS") Program; and

WHEREAS, the City entered into an Interlocal Agreement with Region VIII pursuant to Ordinance Number 2009-12-10-1002, authorizing use of contracts procured by TIPS; and

WHEREAS, the City wishes to utilize the TIPS contract with Silsbee Ford-Lincoln-Mercury, Inc., dba Silsbee Ford Inc., seven replacement Police responder trucks for a total cost of \$335,872.75 for the San Antonio Police Department; and

WHEREAS, funding is available from the FY 2022 Equipment Renewal and Replacement Fund budget; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The offer submitted by Silsbee Ford-Lincoln-Mercury, Inc., dba Silsbee Ford Inc., for seven replacement Police responder trucks for a total cost of \$335,872.75 for the San Antonio Police Department is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation and contract are attached hereto and incorporated herein for all purposes as **Exhibit I**.

SECTION 2. Funding for this ordinance in the amount of \$335,872.75 is available in Fund 72001000, Cost Center 3503200001 and General Ledger 5709080 as part of the Fiscal Year 2023 Adopted Budget approved by City Council.

SECTION 3. Payment is authorized to Silsbee Ford-Lincoln-Mercury, Inc., dba Silsbee Ford Inc., and should be encumbered with a purchase order.

SECTION 4. The financial allocations in this ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

SECTION 5. This ordinance is effective immediately upon passage by eight or more affirmative votes; otherwise, it is effective on the tenth day after passage.
