**ORDINANCE**

**APPROVING THE ACCEPTANCE OF GRANT FUNDS IN  
AN AMOUNT UP TO \$359,806.00 FROM THE U.S.  
DEPARTMENT OF JUSTICE, BUREAU OF JUSTICE  
ASSISTANCE FOR THE CHILD WELFARE STRATEGIC  
ALLIANCE PROGRAM; AND AUTHORIZING AN  
INTERLOCAL AGREEMENT WITH BEXAR COUNTY  
REGARDING THE DISTRIBUTION OF GRANT FUNDS.**

**WHEREAS**, the U.S. Department of Justice (DOJ), Bureau of Justice Assistance (BJA) has available up to \$359,806.00 in 2022 Justice Assistance Grant funds to support the Child Welfare Strategic Alliance Program, a joint project of the City and Bexar County that addresses child sexual abuse and assault; and

**WHEREAS**, of the total grant award, the City would receive \$345,702.00; and

**WHEREAS**, the grant period is October 1, 2021, to September 30, 2025; and

**WHEREAS**, the City's portion of the grant will be used to continue to fund two Detective Investigator positions, who will investigate sexual abuse and assault cases involving children; and

**WHEREAS**, it is also necessary to authorize the execution of an interlocal agreement with Bexar County which designates Bexar County as the grant's fiscal agent, and that provides that Bexar County will conduct the administration of the grant funds; and

**WHEREAS**, there is no cash or in-kind match required; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager or designee, and the San Antonio Chief of Police or designee, is hereby approved to accept grant funds from the DOJ, BJA for the 2022 Justice Assistance Grant in an amount not to exceed \$359,806.00, to support the Child Welfare Strategic Alliance Program, for a grant period beginning October 1, 2020 and ending September 30, 2024.

**SECTION 2.** The City Manager or designee, and the Chief of Police or designee, is hereby authorized to execute an interlocal agreement with Bexar County that designates Bexar County as the grant's fiscal agent, and that provides that Bexar County will conduct the administration of the grant funds. A copy of said agreement is attached hereto as **Exhibit A**, and the terms of the agreement are hereby approved.

**SECTION 3.** The proposed personnel complement of two (2) positions, which is attached hereto and incorporated herein for all purposes as **Exhibit C**, is approved and adopted for entry in the City books.

**SECTION 4.** Upon acceptance of this award, a new fund and internal order number will be created, upon which the sum of up to \$359,806.00 from the DOJ will be appropriated in said fund. The proposed budget, which is attached hereto and incorporated herein for all purposes as **Exhibit B**, is approved and adopted for entry in the City books.

**SECTION 5.** The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 6.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
