ORDINANCE

**AUTHORIZING THE SAN ANTONIO FIRE DEPARTMENT
OFFICE OF EMERGENCY MANAGEMENT TO APPLY
FOR, ACCEPT, AND APPROPRIATE, UPON AWARD UP
TO \$2,800,000.00 FROM THE 2022 URBAN AREA
SECURITY INITIATIVE GRANT PROGRAM AND
AUTHORIZING A PERSONNEL COMPLEMENT OF ONE
POSITION.**

WHEREAS, the Department of Homeland Security announced the San Antonio Urban Area, which encompasses the City, Bexar County, and the thirteen surrounding counties including their suburban cities, was awarded \$3,800,000.00 for 2022 for the Urban Area Security Initiative (UASI) grant program, of which the State of Texas will receive \$190,000.00 for management of this grant, the City will receive \$2,420,064.00, Bexar County will receive \$633,015.00, and other jurisdictions will receive \$556,921.00; and

WHEREAS, the City of San Antonio Fire Department Office of Emergency Management proposes to submit an application for a grant in an amount not to exceed \$2,800,000.00 from the UASI Grant Program, in order to enhance the region's ability to prevent, respond to, and recover from acts of international terrorism impacting the San Antonio Urban Area; and

WHEREAS, the grant funds will allow for a total personnel complement of 1 position which is essential for complying with the federal and state grant management requirements; and

WHEREAS, the grant period would be from October 1, 2022 through September 30, 2025; and

WHEREAS, the grant does not require a cash match or in-kind contribution; **NOW
THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee, and the Emergency Management Coordinator or designee, is authorized to submit a grant application in an amount not to exceed \$2,800,000.00 for the 2022 UASI Grant Program, for the period October 31, 2022 through September 30, 2025, in financial support for the 2022 UASI grant program to fund implementation of the following projects:

- Grant ID ?????? – Southwest Texas Regional Fusion Center (\$190,000)

- Grant ID ?????? – SAFD Protection of Crowded Places & Soft Targes (\$824,324.00)
- Grant ID ?????? – SAPD Protection of Crowded Places & Soft Targes (\$610,330.00)
- Grant ID ?????? – Domestic Violence Extremism (\$150,000.00)
- Grant ID ?????? – Regional Cyber Security (\$200,000.00)
- Grant ID ?????? – Community Preparedness and Resiliency (\$218,552.00)
- Grant ID ?????? – Management and Administration (\$11,978.00) – One fiscal support staff
- Grant ID ?????? – Emergency Management and EOC Sustainment (\$115,000.00)

SECTION 2. The City Manager and designee, and the Emergency Management Coordinator and designee, are further authorized to execute any and all necessary documents to effectuate said application and acceptance, and any additional money awarded under this grant.

SECTION 3. Upon acceptance of this award, a new fund and internal order number will be created, upon which the sum not to exceed \$2,800,000.00 will be appropriated. A final and formal budget, which will include Internal Order numbers and General Ledger numbers, will be submitted by the department upon award.

SECTION 4. The personnel complement of one (1) position, which is attached hereto and incorporated herein for all purposes as **Attachment A**, is approved.

SECTION 5. In the event of loss or misuse of the UASI funds, the City assures that the funds will be returned in full.

SECTION 6. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 7. This ordinance shall take effect immediately upon passage, provided that it is passed by eight or more affirmative votes; otherwise, this ordinance shall take effect ten days from the date of passage.
