

ORDINANCE

**AUTHORIZING THE SAN ANTONIO OFFICE OF EMERGENCY  
MANAGEMENT TO APPLY FOR, ACCEPT, AND APPROPRIATE UPON  
AWARD UP TO \$1,000,000.00 FROM THE 2022 STATE HOMELAND  
SECURITY GRANT PROGRAM.**

**WHEREAS**, there are grant funds of as much as \$1,000,000.00 available from the 2022 state Homeland Security Grant Program (HSGP); and

**WHEREAS**, the purpose of the 2022 HSGP is to enhance the ability of governments to prevent, respond to, and recover from acts of international terrorism and "all hazards" disasters impacting the Alamo Area Council of Government Regions which encompasses the City, Bexar County and the surrounding 13 counties and suburban cities within these counties; and

**WHEREAS**, the grant application by the San Antonio Office of Emergency Management includes a request for funding of one personnel position; and

**WHEREAS**, the total amount of money for the current applications is \$877,229.00, but if another jurisdiction fails to spend their award within the allotted time the Office of the Governor may award additional funds up to a total of \$1,000,000.00 to the City of San Antonio; and

**WHEREAS**, this grant does not require and accept a cash match or an in-kind contribution; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager and designee, and the Emergency Management Coordinator (EMC) and designee, are hereby authorized to submit a grant application and accept grant funds upon award in an amount up to \$1,000,000.00 for the 2022 HSGP to assist the City in preventing, responding to, and recovering from acts of international terrorism and disasters, to fund implementation of the following projects:

- Grant ID 2963808– SAPD Protection of Crowded Places & Soft Targes (\$464,600.00)
- Grant ID 4529301– SAFD Protection of Crowded Places & Soft Targes (\$205,629.00)
- Grant ID 4100803– South Texas Fusion Center & Information Sharing (\$207,000.00)

**SECTION 2.** The City Manager and designee, and the EMC and designee, are hereby authorized to accept said grant, if awarded under substantially the same terms and conditions as applied for, and are further authorized to execute any and all documents necessary to effectuate said application and acceptance, and any additional money awarded under this grant.

**SECTION 3.** Upon acceptance of this award, a new fund and internal order number will be created, upon which the sum not to exceed \$1,000,000.00 will be appropriated from the Office of


the Governor, Homeland Security Grants Division. A final and formal budget, which will include Internal Order numbers and General Ledger numbers, will be submitted by the department upon award.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts, as necessary to carry out the purpose of this Ordinance.

**SECTION 5.** In the event of loss or misuse of the SHSP funds, the City assures that the funds will be returned in full.

**SECTION 6.** This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
