RESCHEDULING CITY COUNCIL MEETINGS IN OCTOBER, NOVEMBER AND DECEMBER 2022, AND JANUARY 2023.

WHEREAS, several City Council members will be attending the Texas Municipal League Annual Conference in October 2022, the National League of Cities Annual Conference in November 2022, and meetings of the first week of December 2022 and early January 2023 need to be rescheduled, partly due to the Winter Break the City observes; and

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:


