It has become an important part of the fabric of our family life In a professional and civic capacity, I came to know HPARC in a very different way when I was contracted to work with them on organizational and board development strategy back in 2017. In the years since, I've gotten to work with Hemisfair staff and volunteers on multiple occasions and truly fell in love with their mission to create a space where all of San Antonio meets. I think spaces like Hemisfair are essential if we are ever to overcome our lamentable distinction as America's most segregated city.
