

ORDINANCE 2022-10-20-0773

APPROVING THE FOLLOWING CONTRACTS ESTABLISHING UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED ANNUAL COST OF \$376,000.00, INCLUDED IN THE RESPECTIVE DEPARTMENT'S FY 2023 ADOPTED BUDGET: (A) HAMPEL OIL DISTRIBUTORS, INC., AND MIDTEX OIL, L.P., FOR BULK DIESEL FLUID; (B) TELLUS EQUIPMENT SOLUTIONS, LLC, FOR JOHN DEERE REPLACEMENT PARTS AND SERVICE; AND (C) C.D.S. PROPERTIES, INC., DBA SOUTHWEST PUBLIC SAFETY, FOR INSTALLATION, REMOVAL, AND REPAIR SERVICES OF SAFETY EQUIPMENT FOR POLICE MOTORCYCLES.

WHEREAS, the City is able to obtain significant savings by purchasing various materials and services on an annual contract basis; and

WHEREAS, the bid submitted by Laredo Gonzalez Auto Parts failed to meet the City's specifications and/or requirements for John Deere replacement parts and service; and

WHEREAS, this ordinance approves contracts with (A) Hampel Oil Distributors, Inc., and Midtex Oil, L.P., for bulk diesel fluid; (B) Tellus Equipment Solutions, LLC, for John Deere replacement parts and service; and (C) C.D.S. Properties, Inc., dba Southwest Public Safety, for installation, removal, and repair services of safety equipment for police motorcycles; and

WHEREAS, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The following bids and offers to furnish the City with goods and services on an annual basis as shown on the attached bid tabulation sheets are hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements: (A) Hampel Oil Distributors, Inc., and Midtex Oil, L.P., for bulk diesel fluid; (B) Tellus Equipment Solutions, LLC, for John Deere replacement parts and service; and (C) C.D.S. Properties, Inc., dba Southwest Public Safety, for installation, removal, and repair services of safety equipment for police motorcycles. The bid tabulation sheets are attached hereto and incorporated herein for all purposes as **Exhibit I**. Copies of the bids are available for inspection in the offices of the Purchasing Division of the Finance Department.



SECTION 4. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.


