### **OVERVIEW**



The Transportation Department is updating the 2011 Bicycle Master Plan with the 2022 Bicycle Network Plan (BNP).

- Existing bicycle gaps needing improvements and prioritization
- Currently a Bronze level Bicycle Friendly City (League of American Bicyclists)
- Demand for safe and focused plan is growing
- Equity, visibility, and quality of progressive opportunities

Contract will provide planning and conceptual design services for a network of bicycle infrastructure; funding and financing strategy and an implementation plan.

# **BACKGROUND AND HISTORY**



- 1<sup>st</sup> Bicycle Master Plan in 1975 recommended a network of 12 corridors but was not adopted by City Council
- Several Alamo Area Metropolitan Planning Organization (AAMPO) led bike plans in 1994, 2001, 2004, 2010
- 2005 Bicycle Master Plan implementation of 1997 City Master Plan
- 2011 San Antonio Bicycle Master Plan and Implementation Strategy led by COSA Office of Environmental Policy - \$150,000 allocated for plan implementation
- SA Tomorrow Plans adopted in 2016
- Bike IMP funding of \$1,000,000 annually began 2016







# **GOALS OF THE BNP UPDATE**




To improve the City's bicycle network with more mileage and increased user demand. Goals include:

- Integrating the Howard Peak Greenway
- Completing a Health Impact Assessment (HIA)
- Provide a Funding Strategy to accompany the Implementation Plan
- Establish performance metrics
- Incorporate city and community initiatives for collective impacts (i.e. Housing & Public Works Bond Projects)


