

ORDINANCE 2022-09-15-0691

**APPROVING THE SETTLEMENT OF LITIGATION STYLED *JESSE FERNANDEZ V. CITY OF SAN ANTONIO*; CAUSE NO. 2018CI22663, IN A TOTAL AMOUNT OF \$210,000.00.**

**WHEREAS**, an auto accident occurred on January 15, 2018 on Frio City Road between Ceralvo Street and Pendleton Avenue involving a City owned vehicle operated by an employee of the San Antonio Police Department and a vehicle driven by Plaintiff Jesse Fernandez; and

**WHEREAS**, as a result of this accident, Jesse Fernandez alleges he suffered injuries and incurred medical expenses and lost wages, and has filed suit seeking to recover damages; and

**WHEREAS**, although the City of San Antonio has vigorously contested this matter, it is in the City's best interest to settle this matter to avoid the uncertainties and risks associated with further litigation; and

**WHEREAS**, the parties have reached an agreement to settle the claims of Jesse Fernandez in the amount of \$210,000 payable from the Self-Insurance Liability Fund subject to City Council approval; **NOW THEREFORE:**


**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The amount of \$210,000.00 is authorized to be paid from Fund 75001000, Insurance Reserve Fund, General Ledger 5402530 General Liability Claims, Cost Center 7509020001 Risk Management-Liability, and is authorized to be made payable as follows: \$210,000.00 will be paid to The Law Offices of Beer & King, P.C. in trust for plaintiff Jesse Fernandez, in settlement of Cause Number 2018CI22663 styled *Jesse Fernandez v. City of San Antonio*.

**SECTION 2.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 3.** This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


