Wade Roscoe, Jerry Huang, James Best, Jenny Liu, Harry Liu, Mark & Sherry Seidenberger, Marya Esparza, Robert McKinney, Nathan Glavy, Yvette Bynum, and Jenise Diaz spoke in opposition to the Zoning Change.

DISCUSSION:

Councilmember Pelaez stated that Joint Base San Antonio (JBSA) and two neighboring Homeowner's Association had approved the Project. Councilmember Pelaez mentioned that his family owned a home just down the street from the development and supported the development. He stated that the developer had agreed to include a deed restriction that limited the number of lots to 55, provided a 30 foot buffer and six foot fence from the adjacent

properties, height restrictions, masonry facades, attached garages, two-car driveways, tree preservation, no more than 50% impervious cover, three acres of preserved public space in addition to no building in the flood plain.

Mayor Nirenberg commented that the City had very little authority to regulate in the ETJ and invited the public to notify their State Legislative representatives that they would like more protections from the City.
