## **ORDINANCE**

AUTHORIZING A PROFESSIONAL SERVICES CONTRACT WITH CENTRO SAN ANTONIO TO PROVIDE CONTINUING SUPPLEMENTAL SAN ANTONIO POLICE PATROL WITHIN THE PUBLIC IMPROVEMENT DISTRICT FOR A SIX-MONTH TERM BEGINNING DECEMBER 1, 2022 AND ENDING MAY 31, 2023 WITH THREE ADDITIONAL SIX-MONTH TERM RENEWAL OPTIONS.

WHEREAS, the City entered into an agreement with Centro San Antonio (CENTRO) to provide additional San Antonio Police patrol in the Public Improvement District; and

WHEREAS, City staff now recommends the patrol be continued within the Public Improvement District; and

WHEREAS, said agreement provides for a six-month term, beginning December 1, 2022 through May 31, 2023 with three additional six-month term renewal options; and

**WHEREAS**, there is no fiscal impact to the CITY as all expenditures are reimbursed by CENTRO; **NOW THEREFORE:** 

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager or designee is hereby authorized to execute a Professional Services Contract with CENTRO for a period beginning December 1, 2022 to May 31, 2023 with three additional six-month term renewal options. A copy of the Professional Services Agreement is attached as Exhibit 1.

**SECTION 2.** Funds received for this ordinance for reimbursements will be deposited in Fund 29616005, Internal Order 217000000132 and General Ledger 6301120.

**SECTION 3**. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This Ordinance becomes effective immediately if passed and approved by eight (8) affirmative votes; otherwise this Ordinance shall take effect ten (10) days from the date of passage.
