

ORDINANCE

APPROVING A TWO-YEAR AGREEMENT WITH BEXAR COUNTY HOSPITAL DISTRICT D/B/A UNIVERSITY HEALTH FOR ONSITE HEALTHCARE SERVICES TO PERSONS IN CUSTODY AT THE DETENTION CENTER AT THE CITY'S FRANK D. WING MUNICIPAL COURT BUILDING, WITH THE OPTION TO RENEW FOR AN ADDITIONAL TWO-YEAR TERM BY MUTUAL AGREEMENT, FOR A TOTAL AMOUNT FOR THE FIRST YEAR NOT TO EXCEED \$842,689.37.

WHEREAS, the City operates and is responsible for the total cost, operations, and services of the detention center at the city's Frank D. Wing Municipal Court Building, the "Arrestee Administrative Processing Center" (AAPC), for individuals arrested by the San Antonio police, Airport Police, and Park Police Departments; and

WHEREAS, the City needs to provide medical screening and treatment to arrestees brought into the facility; and

WHEREAS, the City would like to continue to contract with Bexar County Hospital District d/b/a University Health (University Health) for onsite healthcare services to persons in custody at the AAPC; and

WHEREAS, the initial contract will begin for a period of two (2) years on October 1, 2022 and may be renewed and extended for an additional two (2) years by mutual agreement of the City and University Health; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee is authorized to execute a two-year contract with University Health for an onsite healthcare services to persons in custody at the City's Arrestee Administrative Processing Center, with the option to renew for an additional two year term for a total amount for the first year not to exceed \$842,689.37, with the amount of compensation to be reviewed by both parties thereafter on a yearly basis. The City Manager or designee is authorized to amend this agreement to provide for additional compensation not to exceed five percent for any subsequent year, without further action by City Council. A copy of the contract, in substantial final form, is attached hereto and incorporated herein for all purposes as **Attachment A**.

SECTION 2. Funding for this Ordinance in the amount of \$842.689.37 is available in Fund 11001000, Cost Center 0302060001, General Ledger 5201040 as part of the Fiscal Year 2023 Budget. Additional funding for this Ordinance is contingent upon City Council approval of the City's operating budget and the availability of funds for subsequent Fiscal Years.

SECTION 3. Payment not to exceed the budgeted amount is authorized to Bear County Hospital District d/b/a University Health and should be encumbered with a purchase order.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
