

ORDINANCE 2022-12-01-0904

APPROVING AMENDMENTS TO AGREEMENTS WITH THE CENTER FOR HEALTH CARE SERVICES, FIESTA YOUTH, HEALTHY FUTURES OF TEXAS, SAN ANTONIO AIDS FOUNDATION, AND SAN ANTONIO NEXUS CONNECTION TO EXPAND HIV PREVENTION SERVICES RELATING TO THE ENDING THE HIV EPIDEMIC (EHE) GRANT FOR THE SAN ANTONIO METROPOLITAN HEALTH DISTRICT'S STD/HIV PROGRAM AT NO ADDITIONAL COST FOR TERMS ENDING JULY 31, 2023.

WHEREAS, through Ordinance 2022-01-27-0042, City Council authorized the acceptance of funds from the Texas Department of State Health Services (DSHS) in an amount of up to \$14,163,068.00, for 21 programs encompassing the public health functions of the San Antonio Metropolitan Health District, including the Ending the HIV Epidemic (EHE) grant; and

WHEREAS, the EHE grant aims to advance HIV prevention and surveillance efforts to reduce new HIV infections within marginalized communities of San Antonio; and

WHEREAS, to fulfill requirements of the grant, under the same ordinance, City Council authorized the execution of associated contracts with The Center for Health Care Services, Fiesta Youth, Healthy Futures of Texas, San Antonio AIDS Foundation, and San Antonio Nexus Connection, funded by the EHE grant, for an amount up to \$35,000.00 each; and

WHEREAS, these agreements, in alignment with the EHE grant requirements, served to provide a peer recovery specialist for referrals to substance use disorder treatment programs, HIV and Syphilis testing, outreach, and participation in the End Stigma End HIV Alliance; and

WHEREAS, the current action will approve amendments to the agreements with The Center for Health Care Services, Fiesta Youth, Healthy Futures of Texas, San Antonio AIDS Foundation, and San Antonio Nexus Connection, funded by the EHE grant, and will allow Metro Health to continue to fulfill requirements of the grant to advance HIV prevention and surveillance efforts to reduce new HIV infections within San Antonio; and

WHEREAS, amendments to the initial agreements will extend the services through July 31, 2023 and further provide for continued peer recruitment, linkage to services, HIV testing, outreach services, and expand the participation in the End Stigma End HIV Alliance to include data sharing; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:


SECTION 1. The City Manager or designee, or the Director of the San Antonio Metropolitan Health District or designee, is authorized to approve amendments to agreements with The Center for Health Care Services, Fiesta Youth, Healthy Futures of Texas, San Antonio AIDS Foundation, and San Antonio Nexus Connection for the expansion of education, testing, and outreach services related to HIV

prevention and the Ending the HIV Epidemic (EHE) grant the for San Antonio Metropolitan Health District's (Metro Health) STD and HIV Prevention and Control program, at no additional cost with terms ending July 31, 2023. The amendments to agreements in substantially the same form are attached hereto and incorporated herein for all purposes as **Attachments I and V**.

SECTION 2. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 3. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.



AMENDMENT OF PROFESSIONAL SERVICES AGREEMENT

This Renewal of the Professional Services Agreement is entered into by and between the City of San Antonio, a Texas Municipal Corporation (City) acting by and through its City Manager or designee, pursuant to Ordinance No. 2022-01-27-0042 passed and approved on January 27, 2022 and Healthy Futures of Texas (hereinafter referred to as "CONTRACTOR"), is as follows:

WHEREAS, the San Antonio Metropolitan Health District (Metro Health) accepted grant funds from the DSHS for the "Ending the HIV Epidemic Grant" which funds this Agreement and is made in accordance with awards by the Centers for Disease Control and Prevention (Federal Award Identification number NU62PS92459, CFDA #93.940).; and

WHEREAS, through Ordinance No. 2022-01-27-0042 passed and approved on January 27, 2022, City Council authorized the execution of an Agreement ("Agreement") with Contractor for the provision of education, testing, and outreach services related to HIV prevention by Contractor; and

WHEREAS, said Agreement provided for an initial term expiring on July 31, 2022 with the option to renew for one, one-year terms set out in the Ordinance, subject to mutual agreement of the parties; and

WHEREAS, the parties mutually agreed to a renewal and extension of the initial term of the Agreement from August 1, 2022 to July 31, 2023; and

WHEREAS; in the renewal term Metro Health wishes to expand the services offered by Contractor to align with Metro Health's goals for the second year of the program; and

WHEREAS, the parties wish to amend this Agreement to amend the scope of services to expand services offered; **NOW THEREFORE**:

I. Amendment

Article III of the Agreement is hereby amended to read as follows:

3.1 CONTRACTOR agrees to provide the services described in this Article III entitled Scope of Services in exchange for the compensation described in Article IV Compensation.

3.2 CONTRACTOR shall provide the following services:

3.2.1 Sexual health curriculum implementation & evaluation; HIV prevention activities; monthly participation in End Stigma End HIV Alliance ("ESEHA") as a community organization to provide input on ESEHA goals

3.2.2 CONTRACTOR shall build, test and implement a curriculum designed by young people (ages 13-21). With a specific focus on HIV prevention, the curriculum will prepare youth to engage in healthy relationships and encourage them to take charge of their sexual decision-making and to access healthcare.

3.2.3 The goal of the curriculum will be to prepare youth to engage in healthy relationships and empower them to take charge of their sexual decision-making and to access healthcare. The curriculum design project shall focus on three areas:

1. Involving young people, especially LGBTQ+ youth, as co-designers and co-evaluators.
2. The use of technology to enhance engagement of youth in the educational process.
3. Harnessing the power of peer-to-peer education by empowering young people to lead and teach in their own communities and provide materials, support and training.

3.2.4 CONTRACTOR shall:

1. Gather feedback from partners and clients from Year 2 implementation of The Pride Guide to STIs.
2. Implement the curriculum by holding after school classes and events at campuses of selected ISDs throughout the Bexar County Community and/or through classes provided by CONTRACTOR at their offices.
3. Launch final draft of The Pride Guide to STIs site and create a toolkit for ESEHA partners to use the curriculum by November 10, 2022.
4. Develop training for facilitators on the curriculum by December 15, 2022 and hold four training session for facilitators by March 15, 2023.
5. Align curriculum to 90/90/90 and anti-stigma goals of ESEHA by May 15, 2023.
6. Create marketing and PR plan to share information about the project, its uses, and ESEHA's participation in EHE by June 1, 2023.
7. Monitor usage of site to include but not limited to recording the number of times the curriculum was used, downloaded, completed, shared.
8. Collect data from implementation and report on testing and linkage. Data will be obtained through testing coming from partnership with other EHE organizations that perform tests, monitor and evaluate curriculum. Submit reports on March 10 and June 10 that shall contain aggregate demographic information along with testing numbers and linkage to care numbers, including the number of people tested and the number of people linked to additional medical care.

3.2.5 CONTRACTOR shall actively participate in a monthly sexual health community meeting with the End Stigma END HIV Alliance.

3.3 All work performed by CONTRACTOR hereunder shall be performed to the satisfaction of City, as determined by the Director. The determination made by Director shall be final, binding and conclusive on all Parties hereto. City shall be under no obligation to pay for any work performed by CONTRACTOR, which is not satisfactory to Director. City shall have the right to terminate this Agreement, in accordance with Article VII. Termination, in whole or in part, should CONTRACTOR's work not be satisfactory to Director; however, City shall have no obligation to terminate and may, withhold payment for any unsatisfactory work, as stated herein, even should City elect not to terminate. All scope of services and work to be performed by CONTRACTOR hereunder is outlined hereinabove and no additional work or services other than described herein shall be requested or expected by the City, without prior approval and agreement of all Parties, as evidenced in writing and approved by CONTRACTOR.

All other terms, conditions, covenants and provisions of the Agreement approved through Ordinance No. 2022-01-27-0042, are hereby in effect, renewed and extended, save and except those terms which the Parties have amended.

WHEREAS, through Ordinance No. 2022-01-27-0042 passed and approved on January 27, 2022, City Council authorized the execution of an Agreement ("Agreement") with Contractor for the provision of education, testing, and outreach services related to HIV prevention by Contractor; and

WHEREAS, said Agreement provided for an initial term expiring on July 31, 2022 with the option to renew for one, one-year terms set out in the Ordinance, subject to mutual agreement of the parties; and

WHEREAS, the parties mutually agreed to a renewal and extension of the initial term of the Agreement from August 1, 2022 to July 31, 2023; and

WHEREAS; in the renewal term Metro Health wishes to expand the services offered by Contractor to align with Metro Health's goals for the second year of the program; and

WHEREAS, the parties wish to amend this Agreement to amend the scope of services to expand services offered; **NOW THEREFORE**:

I. Amendment

Article III of the Agreement is hereby amended to read as follows:

3.1 CONTRACTOR agrees to provide the services described in this Article III entitled Scope of Services in exchange for the compensation described in Article IV Compensation.

3.2 In alignment with the Ending the HIV Epidemic Grant program, CONTRACTOR shall provide the following services:

A. Operate their Syringe Services Program ("SSP"). Submit report by end of term to include the following information:

- Return rate, number of participants, gender, age race, ethnicity, zip code

- Number of community organizations visited, community events held, dates of mobile units outreach events, education provided to clients/participants, referrals made per client.

- Return rate measured by the following goals:

- 15% return rate for January 31, 2023
- 20% return rate for July 31, 2023

B. Complete outreach efforts to SUD population conducted within Bexar County to include: visiting other community organizations, reaching out to displaced population (participants without a home address), community events, twice a week mobile unit outreach, partnering with community partners to educate clients/patients, and provide information to SUD population, utilizing social media, flyers and informational handouts, and referral services from other clinics. Maintain 35 unduplicated individuals served each month and reach a minimum of 4 new unduplicated qualified participants a month. Submit report by the end of the term on the following data: total number of individual interactions, SSP demographic data to include: number of people served, any aggregate demographic information required by the Centers for Disease Control and Prevention (CDC).

C. Participate in a monthly sexual health community of practice convening with the End Stigma End HIV Alliance to coordinate with other community organizations and to disseminate and review SSP data, educational materials and outreach plans, and develop long-term goals for promoting sexual health and reducing HIV/ STI transmission among priority populations in Bexar County. Long-term goals shall be reviewed and by Program and CONTRACTOR shall submit a report by the end of the term detailing progress towards completion of said goals.

D. Provide two reports on harm reduction efforts being made across the community. Reports will include the organizations CONTRACTOR has established MOUs with, activities related to harm reduction that have been conducted by the partnering organization, etc. CONTRACTOR shall submit the first report on February 10, 2023 and the second report on August 10, 2023.

3.3 All work performed by CONTRACTOR hereunder shall be performed to the satisfaction of City, as determined by the Director. The determination made by Director shall be final, binding and conclusive on all Parties hereto. City shall be under no obligation to pay for any work performed by CONTRACTOR, which is not satisfactory to Director. City shall have the right to terminate this Agreement, in accordance with Article VII. Termination, in whole or in part, should CONTRACTOR's work not be satisfactory to Director; however, City shall have no obligation to terminate and may, withhold payment for any unsatisfactory work, as stated herein, even should City elect not to terminate. All scope of services and work to be performed by CONTRACTOR hereunder is outlined hereinabove and no additional work or services other than described herein shall be requested or expected by the City, without prior approval and agreement of all Parties, as evidenced in writing and approved by CONTRACTOR.

Section 4.1 of the Agreement is hereby amended to read as follows:

4.1 In consideration of CONTRACTOR's performance in a satisfactory and efficient manner, as determined solely by Director, of all services and activities set forth in this Agreement, City agrees to pay CONTRACTOR an amount not to exceed THIRTY FIVE THOUSAND DOLLARS AND 00/100THS (\$35,000.00) as total compensation to be paid to CONTRACTOR in the manner set forth below:

- 4.1.1 1st invoice for a total amount of \$8,750 due Nov. 10, 2022
- 4.1.2 2nd invoice for a total amount of \$8,750 due Feb. 10, 2022
- 4.1.3 3rd invoice for a total amount of \$8,750 due May 10, 2022
- 4.1.4 4th invoice for a total amount of \$8,750 due Aug. 10, 2022

WHEREAS, said Agreement provided for an initial term expiring on July 31, 2022 with the option to renew for one, one-year terms set out in the Ordinance, subject to mutual agreement of the parties; and

WHEREAS, the parties mutually agreed to a renewal and extension of the initial term of the Agreement from August 1, 2022 to July 31, 2023; and

WHEREAS; in the renewal term Metro Health wishes to expand the services offered by Contractor to align with Metro Health's goals for the second year of the program; and

WHEREAS, the parties wish to amend this Agreement to amend the scope of services to expand services offered; **NOW THEREFORE**:

I. Amendment

Article III of the Agreement is hereby amended to read as follows:

3.1 CONTRACTOR agrees to provide the services described in this Article III entitled Scope of Services in exchange for the compensation described in Article IV Compensation.

3.2. In alignment with the Ending the HIV Epidemic Grant program, CONTRACTOR shall provide the following services:

- A. Reduce stigma and prevent the spread of HIV and STIs among teens in Bexar County through education and collaboration with schools and community partners by:
 - 1. Reducing new HIV/STI transmission in teens and young adults
 - 2. Increasing participants' perceived vulnerability to HIV/STI infection

3. Increasing participants' knowledge about which behaviors place that at risk for HIV/STI infection
4. Empower participants to have a sense of "ownership" of their sexual health
5. Empower parents and caregivers to be confident in their fact-based discussions with their teens about sexual health and LGBTQ+ identity.

B. Disseminate the updated "You're the Cure" curriculum in the current school districts: NISD, AHISD, and SAISD. CONTRACTOR shall educate 9,000 students by May 30, 2023. Submit report, by the end of the term, indicating the ISDs within Bexar County that have received the updated curriculum and the number of students that have participated in receiving the curriculum.

C. Expand "You're the Cure" program in underserved school districts in the South, West, and East sides of Bexar County. These include: Harlandale ISD, East Central ISD, Edgewood ISD, South San ISD and Southwest ISD.

1. Coordinate with School Health Advisory Councils (SHACs) from at least four of these districts by October 2022.
2. Present to and receive approval from school boards by Dec 2022.
3. Establish MOUs with at least four of these districts by December 2022.
4. Present program in four of these districts by May 30, 2023.

D. Quantify knowledge retention by offering pre and post course surveys if approved by school districts. Assessments will be offered digitally or on paper, as desired by the student. Based on previous assessments, CONTRACTOR's goal is to increase their knowledge about HIV and STIs by 75%.

E. Expand Peer to Peer program outreach efforts to include community groups outside schools to include athletics organizations, neighborhood groups, and other community organizations. CONTRACTOR shall conduct at least two events by March 30, 2023.

F. Continue sexual health curriculum to include LGBTQ+ health concerns for teens to be shared with parents and/or caregivers. CONTRACTOR shall conduct at least two focus groups of parents/caregivers to review curriculum by June 30, 2023. CONTRACTOR shall submit a report after each focus group which includes a summary of new findings and changes made to the original curriculum.

G. Participate in monthly End Stigma End HIV Alliance (ESEHA) sexual health community of practice convenings to coordinate with other community organizations and to review data, educational materials and outreach plans, and develop long-term goals for promoting sexual health and reducing HIV/ STI transmission among priority populations in Bexar County. Submit a report by the end of the term detailing the number of focus groups, outreach efforts, and number of classes offered covering their sexual health curriculum to include school districts in Bexar County and local colleges and universities.

3.3 All work performed by CONTRACTOR hereunder shall be performed to the satisfaction of City, as determined by the Director. The determination made by Director shall be

final, binding and conclusive on all Parties hereto. City shall be under no obligation to pay for any work performed by CONTRACTOR, which is not satisfactory to Director. City shall have the right to terminate this Agreement, in accordance with Article VII. Termination, in whole or in part, should CONTRACTOR's work not be satisfactory to Director; however, City shall have no obligation to terminate and may, withhold payment for any unsatisfactory work, as stated herein, even should City elect not to terminate. 3.2 In alignment with the Ending the HIV Epidemic Grant program, CONTRACTOR shall provide the following services:

- A. Conduct monthly classes on Sexual Health and HIV/AIDS based on the 4 topics listed below.
 - i. What is HIV/AIDS and how do we beat the stigma around it?
 - ii. History of HIV/AIDS discrimination and how it has affected our community.

- iii. HIV stigma in the BIPOC communities.
 - iv. HIV/AIDS rates among LGBTQ+ youth.
 - a. Monthly classes shall be held at an ISD, either in person or virtually, provided through afterschool programming.
 - b. Classes shall also be available at their office location, both in person and online.
 - c. Offer a minimum of one 60 minute class per month to youth ages 12-18 and/or young adults ages 18-22 at their office location and may host additional classes based upon their capacity and calendar of programming events.
 - d. Distribute HIV information packets to participants of the classes in either electronic or paper form and provide information packets to partnering agencies for distribution.
 - e. Submit a monthly report detailing the number of participants, topics and agenda presented upon, speakers that presented at the monthly classes and their association with the organization or topic being discussed.
- B. Reach out to local San Antonio School Districts (SAISD, NSISD, Harlandale) along with the college campuses of UTSA and Alamo Colleges District to form a partnership to conduct the following if approved by the individual schools within the district/campus.
- a. Conduct a minimum of one 60-minute sexual health/HIV/STI educational class to youth ages 12-18 and/or young adults ages 18-22 at their school location and may host additional classes based upon their capacity and calendar of programming events and approval of all parties involved once a quarter for the 2022-2023 year.
 - b. Distribute HIV information packets to participants of the classes in either electronic or paper form and provide information packets to partnering agencies for distribution as needed.
 - c. Submit a Quarterly Report detailing the number of participants, topics and agenda presented upon, speakers that presented at the monthly classes and their association with the organization or topic being discussed.
- C. Provide routine HIV screening services as an integrated standard of care in a health care setting to all eligible participants within the organization.
- a. Conduct quarterly mobile HIV /STI Screening services in partnership with Metro Health Mobile Testing Services with Fiesta Youth eligible participants in accordance with Fiesta Youth and Young Adult monthly programming schedule.
- D. Collaborate with other ESEHA participating organizations to determine youth/ community advocates for a panel discussion on sexual health and or HIV/AIDS education/awareness to be completed in 1st quarter of 2023 and deliver panel discussions in a community/organizational forum. These panelists can be youth advocates, doctors, phycologist, or community leader that can speak to the precautions/adversities of sexual health or the HIV/AIDS epidemic itself.
- E. Participate in monthly ESEHA sexual health community of practice convenings to coordinate with other community organizations and to review data, educational materials, and outreach plans, and develop long-term goals for promoting sexual health and reducing HIV/ STI transmission among priority populations in Bexar County.

- F. Host a week-long HIV/AIDS awareness, education and remembrance community event, and AIDS Memorial Quilt display, in conjunction with local organizations, for approximately 2,000 participants with the goal of providing information on services and resources offered by Fiesta Youth, including promoting Metro Health's HIV/STD programs.

3.3 All work performed by CONTRACTOR hereunder shall be performed to the satisfaction of City, as determined by the Director. The determination made by Director shall be final, binding and conclusive on all Parties hereto. City shall be under no obligation to pay for any work performed by CONTRACTOR, which is not satisfactory to Director. City shall have the right to terminate this Agreement, in accordance with Article VII. Termination, in whole or in part, should CONTRACTOR's work not be satisfactory to Director; however, City shall have no obligation to terminate and may, withhold payment for any unsatisfactory work, as stated herein, even should City elect not to terminate. All scope of services and work to be performed by CONTRACTOR hereunder is outlined hereinabove and no additional work or services other than described herein shall be requested or expected by the City, without prior approval and agreement of all Parties, as evidenced in writing and approved by CONTRACTOR.

Section 4.1 of the Agreement is hereby amended to read as follows:

4.1 In consideration of CONTRACTOR's performance in a satisfactory and efficient manner, as determined solely by Director, of all services and activities set forth in this Agreement, City agrees to pay CONTRACTOR an amount not to exceed THIRTY-FIVE THOUSAND DOLLARS AND 00/100THS (\$35,000.00) as total compensation to be paid to CONTRACTOR in the manner set forth below:

- 4.1.1 1st invoice for a total amount of \$8,750 due Nov. 10, 2022
- 4.1.2 2nd invoice for a total amount of \$8,750 due Feb. 10, 2022
- 4.1.3 3rd invoice for a total amount of \$8,750 due May 10, 2022
- 4.1.4 4th invoice for a total amount of \$8,750 due Aug. 10, 2022



**RENEWAL AND EXTENSION OF
PROFESSIONAL SERVICES AGREEMENT**

This Renewal of the Professional Services Agreement is entered into by and between the City of San Antonio, a Texas Municipal Corporation (City) acting by and through its City Manager or designee, pursuant to Ordinance No. 2022-01-27-0042 passed and approved on January 27, 2022 and The Center for Health Care Services (hereinafter referred to as "CONTRACTOR") a political subdivision of the State of Texas, is as follows:

WHEREAS, the San Antonio Metropolitan Health District accepted grant funds from the DSHS for the "Ending the HIV Epidemic Grant" which funds this agreement and is made in accordance with awards by the Centers for Disease Control and Prevention (Federal Award Identification number NU62PS92459, CFDA #93.940).; and

WHEREAS, through Ordinance No. 2022-01-27-0042, passed and approved on January 27, 2022, City Council authorized the execution of an Agreement with Contractor related to the provision of education, testing, and outreach services related to HIV prevention by Contractor; and

WHEREAS, said Agreement provided for an initial term expiring on July 31, 2022 with the option to renew for one, one-year terms set out in the Ordinance, subject to mutual agreement of the parties; and

WHEREAS, the parties mutually agreed to a renewal and extension of the initial term of the Agreement from August 1, 2022 to July 31, 2023; and

WHEREAS, the parties now wish to exercise their option to renew and extend this Agreement for an additional one year term from August 1, 2022 to July 31, 2023; **NOW THEREFORE:**

I. Renewal

Pursuant to the provisions of the Agreement, City and Contractor mutually agree to renew and extend the term of said Agreement for an additional period of one year, commencing on August 1, 2022 and terminating July 31, 2023, under the same terms and conditions as stated in said Agreement.

II.

All other terms, conditions, covenants and provisions of the Agreement approved through Ordinance No. 2022-01-27-0042, are hereby renewed and extended.
