FIFTH AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT FOR DISTRICT AND PROGRAM LEADER SERVICES, EARLY LEARNING LEADERSHIP PROGRAMS AND PROFESSIONAL DEVELOPMENT MATERIALS FOR SAN ANTONIO EARLY CHILDHOOD EDUCATION MUNICIPAL DEVELOPMENT CORPORATION (Pre-K 4 SA)

This amendment is entered into by and between the San Antonio Early Childhood Education Municipal Development Corporation (hereinafter referred to as "CORPORATION" or "Pre-K 4 SA"), and New Teacher Center (hereinafter referred to as "CONSULTANT"), both of which may be referred to herein collectively as the "Parties".

The Parties hereto severally and collectively agree, and by the execution hereof are bound, to the mutual obligations herein contained and to the performance and accomplishment of the tasks hereinafter described.

WHEREAS, the CORPORATION entered into a contract with CONSULTANT for Training Services pursuant to an Agreement (hereinafter referred to as "the Agreement") that commenced on August 7, 2018 and extended through June 30, 2022;

WHEREAS, the authorized Agreement value has not been exhausted and allows the Parties to negotiate the provision of additional services that are complementary to the existing scope of services in the Agreement;

WHEREAS, the Parties previously entered into a no cost extension the Agreement through June 30, 2024 with no increase in the value of the Agreement in order to continue providing services;

NOW THEREFORE, CORPORATION and the CONSULTANT agree to amend the Agreement as follows:

- 1. Section 3.1 is amended to read as follows:
 - 3.1 Consultant agrees to provide the services described in Attachment A, entitled Scope of Services in exchange for the compensation described in Article IV, Compensation.
- 2. Attachment A, entitled "Scope of Services," supersedes all prior attachments and represents the Scope of Services provided by Consultant throughout the term of the Agreement. Any other attachments intending to represent the Scope of Services are hereby deleted in favor of this Attachment A.

3. All other terms, conditions, covenants and provisions of the Agreement are hereby continued and shall remain in effect in their original form, except for the provisions modified by this Amendment.
