APPROVING A STREET NAME CHANGE OF "ENRIQUE M BARRERA PARKWAY" TO "HISTORIC OLD HWY 90", WITH AN ASSOCIATED MEMORIAL DESIGNATION OF "ENRIQUE M BARRERA MEMORIAL WAY", BETWEEN U.S. HWY 90 ACCESS AND SOUTH SAN GABRIEL AVE.

WHEREAS, on September 3, 2015, the City Council adopted Ordinance No. 2015-09-03-0747 to change the street name of Old Hwy 90 to Enrique M Barrera Parkway with the memorial designation of "Historic Old Hwy 90" through a City Council Request, and on July 19, 2016, an application was submitted to change the street name back to Old Hwy 90 W, which was denied; and

WHEREAS, on May 5th, 2017, Ordinance 2017-05-04-0296 was passed so that a street name change could not be altered for a term of 5 years from when it was approved by City Council, and this street name change request is being submitted by Michael Cooremans to change the street name of Enrique M Barrera Parkway to Historic Old Hwy 90 and was received more than 5 years after the last street name change; and

WHEREAS, staff began implementing this request through the street renaming process as required by Chapter 6 of the City Code; and

WHEREAS, staff forwarded the request to all City of San Antonio departments and outside agencies for review, and no opposition has been identified; and

WHEREAS, staff conducted a technical review finding it to conform to City Code requirements for street renaming; and

WHEREAS, staff properly posted and mailed notice of this request to over 190 property owners abutting the segment of the street, notice requirements for renaming of the street have been satisfied in accordance with Chapter 6 of the City Code; and

WHEREAS, the Planning Commission held a public hearing on January 12, 2022, allowing all interested persons to be heard and recommended approval of changing the name to Historic Old Hwy 90; and

WHEREAS, the COSA Public Works Department is working with the Texas Department of Transportation (TxDoT) on finalizing costs for signage on TxDoT right-of-way, and will bring a funding agreement to City Council for consideration in the near future; and

WHEREAS, Council District 6 and the applicant will be responsible for the costs associated with this application. NOW THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. "Enrique M Barrera Pkwy" located in City Council Districts 5 and 6, between U.S. Hwy 90 access and South San Gabriel Ave, is hereby renamed "Historic Old Hwy 90", with an associated memorial designation of "Enrique M Barrera Memorial Way". All naming requirements of Chapter 6 of the City Code have been met. The location is more specifically depicted in Attachment 1. City staff is directed to provide appropriate signage to this effect, and to work with Texas Department of Transportation on the replacement of signs located in State right-of-way.

SECTION 2. Funds generated by this ordinance in the amount of \$1,859.50 will be deposited into Fund 29097000, Internal Order 229000000000, and General Ledger Account 4406775. Funds are authorized to be appropriated per the attached program budgets.

SECTION 3. Funds generated by this ordinance in the amount of \$3,228.00 will be deposited into Fund 11001000, Internal Order 223000000158, and General Ledger Account 6301120. Funds are authorized to be appropriated per the attached program budgets.

SECTION 4. Funding in the amount of \$3,228.00 for this ordinance is available in Fund 11001000, Cost Center 2312020001, and General Ledger 5301030 as part of the Fiscal Year 2022 budget.

SECTION 5. Funding in the amount of \$158,272.00 for this ordinance is available in Fund 11001000, Cost Center 0106010001, and General Ledger 5406539 as part of the Fiscal Year 2022 budget.

SECTION 6. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 7. This Ordinance is effective immediately upon receipt of eight affirmative votes; otherwise, it is effective 10 days after passage.


