WHEREAS, through ordinance 2022-05-12-0337 the San Antonio Metropolitan Health District (Metro Health) accepted \$75,000.00 in funds for the National Association of County and City Health Officials (NACCHO) for the Medical Reserve Corps (MRC) COVID-19 Respond, Innovate, Sustain, and Equip (RISE) Grant; and

WHEREAS, in October of 2022, the grantor announced a contract extension to the grant and additional funds in the amount of 35% of the original award; and

WHEREAS, the MRC COVID-19 RISE funding opportunity is intended to provide resources to the MRC network to support COVID-19 and other public health emergency response efforts; and

WHEREAS, through this additional funding, Metro Health's Public Health Emergency Preparedness (PHEP) Program will support training opportunities for Alamo Area Medical Reserve Corp members; and

WHEREAS, in addition, funds will support Metro Health Staff's attendance at the 2023 Texas Division of Emergency Management Conference scheduled for the summer of 2023; and

WHEREAS, this funding will contribute to the efficient operations of the MRC which in turn will assist Metro Health and the community; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee or the Director of the San Antonio Metropolitan Health District or designee is authorized to accept additional funds from the National Association of County and City Health Officials (NACCHO) for the Medical Reserve Corps (MRC) COVID-19 Respond, Innovate, Sustain, and Equip (RISE) Grant in the amount of \$26,250.00 for a total grant amount of \$101,250.00 for a period ending June 30, 2023.

SECTION 2. Funds received for this ordinance for MRC COVID-19 RISE Grant will be deposited in Fund 3619010000, Internal Order 836000000188 and funds are authorized to be appropriated per the attached budget attached hereto and incorporated herein for all purposes as **Attachment-I.**

SECTION 4. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
