The City Council convened a regular meeting in the Norma S. Rodriguez Council Chamber in the Municipal Plaza Building beginning at 9:08 AM. City Clerk Debbie Racca-Sittre took the Roll Call noting a quorum with the following Council Members present:

1. Invocation

The invocation was delivered by Reverend Douglas Randle, Jr. of Bethany Missionary Baptist Church, guest of Councilmember Cabello Havrda, Council District 6.

2. Pledge of Allegiance

Mayor Nirenberg led the assembly in the Pledge of Allegiance.

POINT OF PERSONAL PRIVILEGE

Mayor Nirenberg led a moment of silence for the death of local Artist and Vietnam Veteran Jesse Trevino. Councilmember Castillo read a biography of Trevino and noted the numerous artworks by Trevino located on the West side of San Antonio. Councilmembers Cabello Havrda and Viagran spoke in honor of the life and contributions of Trevino.

Mayor Nirenberg invited children from Essence Preparatory Elementary School to perform a song in honor of Black History Month.

Mayor Nirenberg welcomed Congressman Greg Casar representing District 35 in the Texas House of Representatives.

Mayor Nirenberg proclaimed February 19-26, 2023 Texas Trail Roundup Walk Festival week in San Antonio and invited members of the International Volkssport Verband Olympiad and International Marching League to speak.

Councilmember Viagran recognized the Digital Inclusion Team.

Councilmember Rocha Garcia recognized the Ukrainian community in San Antonio and medical supply drives supporting the war in Ukraine and invited members of the community to a vigil honoring the lives lost. Members of the Ukrainian community in San Antonio spoke.

Mayor Nirenberg recognized the Japanese internments at Ft. Sam Houston that occurred during World War II in 1942 and read a proclamation in honor of Day of Remembrance of Japanese Incarceration February 19, 2023. Members of the Japan-American Society San Antonio spoke.

Mayor Nirenberg reconvened the meeting in Open Session at 10:14 a.m. and announced that no official action had been taken in Executive Session.

STAFF BRIEFING

4. Certifying the results of the verification process of the San Antonio Justice Charter Amendment Petition. [Debbie Racca-Sittre, City Clerk]

City Clerk Debbie Racca-Sittre provided an overview and timeline of the petition process including relevant laws and requirements. Racca-Sittre stated that her office had completed review of the petition on February 8, 2023 which was 20 business days after it had been submitted. The process included a line-by-line review of each signature using the Bexar County Voter Elections Management and Compliance System.

Racca-Sittre reported that of the 36,776 signatures checked, 20,979 were valid. She noted that under the Texas Local Government Code, 20,000 valid signatures were required to place the item on the ballot. Racca-Sittre certified that the petition was sufficient and recommended that City Council perform its ministerial duty to order the charter amendment election for May 6, 2023.

No action was required for Item 4.

City Attorney Andy Segovia further clarified that the City Council was required under State law to order an election as a result of the petition being certified as sufficient.

PUBLIC COMMENT

Mayor Nirenberg called all members of the Public signed up to speak on Items 4 and 20 as both were related to the petition and no vote had been taken.

Fr. Henry Clay Hunt, Cesario Garcia, Michael Osbourn, Susan Bayne, Jack Finger, Ernest Salinas, Rose Hill, Jason Sanchez, Betty Eckert, Denise Gutierrez, Sandra Crocker, Ashley Sosa, John "Danny" Diaz (president of the San Antonio Police Officer's Association) spoke in opposition to the SA Justice Charter Amendment. Patrick Von Dolen stated that the petition should be separated into separate ballot measures and he provided a letter from Attorney General Ken Paxton.

Ananda Tomas, Executive Director of Act 4 SA (representing the petitioner), Aaron Arguello, William Johnson, Lil Ost, Fernando Aguilar, Diana Flores Uriegas, Victoria Ramirez, Kelly Gonzalez, and Mohammad Rasool spoke in support of the SA Justice Charter Amendment and several persons commented that the ballot language was too long.

Debra Ponce commented that the voters needed to decide on the SA Justice Charter Amendment.

Mayor Nirenberg noted that the Item was for briefing only. There was no discussion by City Council.
