#### **ORDINANCE**

AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION AND ACCEPTANCE OF FUNDS UPON AWARD IN AN AMOUNT UP TO \$2,178,947.00 INCLUDING THE ACCEPTANCE OF ADDITIONAL GRANT FUNDS UP TO 20% OF THE GRANT, FROM THE OFFICE OF NATIONAL DRUG CONTROL POLICY FOR A HIGH INTENSITY DRUG TRAFFICKING AREA GRANT, AND **ESTABLISHING BUDGET** AND **PERSONNEL** A COMPLEMENT OF SEVENTEEN POSITIONS FOR THE **PERIOD** JANUARY 1. 2023 **THROUGH** GRANT **DECEMBER 31, 2024.**

**WHEREAS**, the Office of National Drug Control Policy (ONDCP) has grant funds available to the San Antonio Police Department (SAPD) in an amount up to \$2,178,947.00 to fund the San Antonio High Intensity Drug Trafficking Area (HIDTA) Initiative; and

WHEREAS, the HIDTA mission is to reduce drug trafficking in the San Antonio metropolitan area by instituting innovative narcotic enforcement investigations and the seizure of illegally obtained assets in an effort to reduce the profitability of narcotics trafficking; and

WHEREAS, said grant would maintain funding for seventeen positions; and

WHEREAS, the grant period would be January 1, 2023 through December 31, 2024; and

WHEREAS, no City matching funds are required; NOW THEREFORE:

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager and designee, and the San Antonio Chief of Police and designee, are hereby authorized to submit a grant application, and accept grant funds upon award, in an amount up to \$2,178,947.00 from the ONDCP for the 2023 HIDTA grant for the period beginning January 1, 2023 through December 31, 2024. A copy of said application is on file with the San Antonio Police Department.

**SECTION 2.** The City Manager or designee, or the San Antonio Chief of Police or designee, are hereby further authorized to execute any and all necessary documents to effectuate said application and acceptance, and amendments which will provide supplemental grant funds to the grant by the

funding agency in an amount up to 20% of the total amount initially awarded to the grant, with no cash match or personnel complement changes.

**SECTION 3.** Should funding be awarded, new funds and Internal Orders will be created for use in the accounting for the fiscal transaction in the acceptance of this grant and a sum not to exceed \$2,178,947.00 will be appropriated in said funds. The budget, which is attached hereto and incorporated herein for all purposes as **Exhibit A**, is approved and adopted for entry in the City books.

**SECTION 4.** A personnel complement of seventeen (17) positions, which is attached hereto and incorporated herein for all purposes as **Exhibit B**, is approved.

**SECTION 5.** The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 6.** This ordinance shall take effect immediately upon passage, provided that it is passed by eight or more affirmative votes; otherwise, this ordinance shall take effect ten days from the date of passage.
