

**ZONING DESCRIPTION  
FOR  
A 1.897 ACRE TRACT  
(C-3)**

A **1.897 acre** tract of land, situate in the AJ Leslie Survey Number 99, Abstract 447, New City Block 12495, City of San Antonio, Bexar County, Texas, and being a portion out of Block 6 of the Senisa Terrace Subdivision, a plat of record in Volume 3700, Page 43 of the Deed and Plat Records of Bexar County, Texas (D.P.R.), a portion of a 3.412 acre tract of land, called Lot A-2, as conveyed to John Anthony Yamaguchi of record in Document No. 20210073524 of the Official Public Records of Bexar County, Texas (O.P.R.) and all of a called Lot A-1 also conveyed to John Anthony Yamaguchi in Document No. 20210073523 (O.P.R.) and being more particularly described by metes and bounds as follows:

**BEGINNING** at a found  $\frac{1}{2}$ " iron rod in the north right-of-way line of S.W. Military Drive (Loop 13), a variable width right-of-way, for the southeast corner of the remaining portion of a 3.844 acre tract as described in Volume 6153, Page 204 (O.P.R.), the southwest corner of Lot A-2 and the tract described herein, from which a found iron pipe for the southwest corner of the remaining portion of said 3.844 acre tract bears N 84°13'56" W, a distance of 234.92 feet;

**THENCE: N 00°21'19" W**, along and with the west line of Lot A-2 and the east line of said 3.844 acre tract, a distance of **310.83 feet** to a calculated point for the northwest corner of the tract described herein, from which a found  $\frac{1}{2}$ " iron rod for the northeast corner of said 3.844 acre tract and the southeast corner of Lot 9, Block 6 of the Morrow Medical Park Subdivision, a plat of record in Volume 9536 Page 102 (D.P.R.) bears N 00°21'19" W, a distance of 128.85 feet;

**THENCE: N 89°22'47" E**, into and across Lot A-2, a distance of **255.10 feet** to a calculated point in the west right-of-way line of Barlite Blvd., an 80' wide right-of-way, and the east line of Lot A-2, for the northeast corner of the tract described here, from which a found iron pipe at the intersection of Barlite Blvd. with McCauley Blvd., a 60' right-of-way, for the northeast corner of Lot A-2 bears N 00°14'18" E, a distance of 352.00 feet;


**THENCE: S 00°14'18" E**, along and with the west right-of-way line of Barlite Blvd., the east line of Lot A-2 and Lot A-1, a distance of **309.30 feet** to a set mag nail with a washer stamped "KFW SURVEYING" at the intersection of Barlite Blvd. with S.W. Military Drive, for a point of curvature to the right of Lot A-1 and the tract described herein;

**THENCE:** with the curve to the **right** having an arc of **45.24 feet**, a radius of **26.98 feet**, a delta of **96°04'00"** and a chord bears **S 47°44'04" W**, a distance of **40.12 feet** to a set mag nail with a washer stamped "KFW SURVEYING" to a point of tangency of Lot A-1 and the tract described herein;

**THENCE: N 84°13'56" W**, along and with the north right-of-way line of S.W. Military Drive and the south line of Lot A-1, at a distance of 126.00 feet passing a found ½" iron rod for the southwest corner of Lot A-1 and the southerly southeast corner of Lot A-2, and continuing along and with the north right-of-way line of S.W. Military Drive and the south line of Lot A-2, for a total distance of **225.89 feet** to the **POINT OF BEGINNING** and containing **1.897 acres** more or less, in the City of San Antonio, Bexar County, Texas. Said tract being described in accordance with a survey prepared by KFW Surveying. Bearings are based on NAD83 Texas State Plane South Central Zone.
