ZONING DESCRIPTION FOR A 2.067 ACRE TRACT (C-3NA)

COMMENCING at a found ½" iron rod in the north right-of-way line of S.W. Military Drive (Loop 13), a variable width right-of-way, for the southeast corner of the remaining portion of a 3.844 acre tract as described in Volume 6153, Page 204 (O.P.R.), the southwest corner of Lot A-2 and the tract described herein, from which a found iron pipe for the southwest corner of said 3.844 acre tract bears N 84°13′56″ W, a distance of 234.92 feet;

THENCE: N 00°21'19" W, along and with the west line of Lot A-2 and the east line of said 3.844 acre tract, a distance of 310.83 feet to a calculated point for the **POINT OF BEGINNING** and the southwest corner of the tract described herein;

THENCE: N 00°21′19″ W, continuing along and with the west line of Lot A-2 and the east line of said 3.844 acre tract, at a distance of 128.85 feet passing a found ½" iron rod for the northeast corner of said 3.844 acre tract and the southeast corner of Lot 9, Block 6 of the Morrow Medical Park Subdivision, a plat of record in Volume 9536 Page 102 (D.P.R), continuing along and with the west line of Lot A-2 and the east line of Lot 9, for a total distance of 352.86 feet to a found ½" iron rod with a Plastic Cap Stamped "CLARK GEOGRAM" in the south right-of-way line of McCauley Blvd., a 60' wide right-of-way, for the northeast corner of Lot 9, the northwest corner of Lot A-2 and the tract described herein, from which a found iron pipe for a point of curvature Lot 9 bears N89°34′21″E, a distance of 103.79 feet;

THENCE: N 89°34′21″ E, along and with the south right-of-way line of McCauley Blvd. and the north line of Lot A-2, a distance of 255.81 feet to a found iron pipe at the intersection of Barlite Blvd., a 80′ wide right-of-way, with McCauley Blvd., for the northeast corner of Lot A-2 and the tract described herein;

THENCE: S 00°14′18″ E, along and with the west right-of-way line of Barlite Blvd. and the east line of Lot A-2, a distance of 352.00 feet to a calculated point for the southeast corner of the tract described herein, from which a set mag nail with a washer stamped "KFW SURVEYING" at the intersection of Barlite Blvd. with S.W. Military Drive, for a point of curvature to the right of Lot A-1 bears S00°14′18″E, a distance of 309.30 feet;

THENCE: S 89°22'47" W, into and across Lot A-2, a distance of 255.10 feet to the POINT OF BEGINNING and containing 2.067 acres more or less, in the City of San Antonio, Bexar County, Texas. Said tract being described in accordance with a survey prepared by KFW Surveying. Bearings are based on NAD83 Texas State Plane South Central Zone.
