## METES AND BOUNDS DESCRIPTION

3.14 ACRES

SAN ANTONIO, BEXAR COUNTY, TEXAS

**3.14 ACRE TRACT OF LAND SITUATED IN THE CITY OF SAN ANTONIO, NEW CITY BLOCK 34670, BEXAR COUNTY, TEXAS AND BEING A PORTION OF THE REMAINDER OF A 242.471 ACRE TRACT OF LAND CONVEYED TO 242 CRESTA BELLA, LTD OF RECORD IN VOLUME 12602, PAGE 1845 OF THE OFFICIAL PUBLIC RECORDS OF BEXAR COUNTY, TEXAS.**

**BEGINNING** at point in the west right-of-way line of Camp Bullis Road and southeast corner of Lot 902 of the Cresta Bella Subdivision, Unit 2A of record in Volume 9669, Pages 157-158 of the Deed and Plat Records of Bexar County, Texas for the northeast corner of the remainder of the 242.471 acres and this tract.

**THENCE**, with the east line of this tract and the remainder of the 242.471 acres and the west line of Camp Bullis Road the following two (2) calls:

1. South 03°01'03" East 174.92 feet to a point for the beginning of a curve to the left, and
2. Curve to the left with a Radius of 710.87, length of 164.10 feet, chord bearing of South 09°21'11" East, chord of 163.73 feet to a point for the southeast corner of this tract.

**THENCE**, North 50°56'48" West 457.61 feet with the southwest line of this tract cutting into the remainder of the 242.471 acre tract running 30 feet north and parallel with Lots 17-21 of the Walden Heights Subdivision, Unit 6 of record in Volume 9520, Pages 191-194 of the Deed and Plat Records of Bexar County, Texas to a point for the southwest corner of this tract.

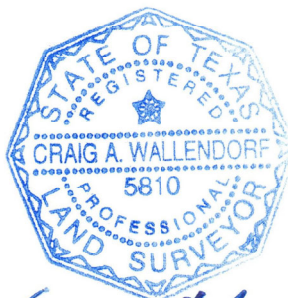
**THENCE**, with the west and northwest line of this tract cutting across the remainder of the 242.471 acre tract the following two (2) calls:

1. North 03°01'03" West 269.16 feet to a point for the northwest corner, and
2. North 82°34'18" East 201.82 feet to a point in the southwest line of Lot 902 for a north corner of this tract.

**THENCE**, South 79°23'14" East 232.01 feet with the northeast line of this tract and the remainder of the 242.471 acre tract and the southwest line of Lot 902 to the **POINT OF BEGINNING** and containing 3.14 acres of land subject to any and all easements, setbacks, conveyances, right-of-way and restrictions that may affect.
