**RESOLUTION**

**OF NO OBJECTION FOR WINSTON ROSELAWN APTS, LP'S APPLICATION TO THE TEXAS DEPARTMENT OF HOUSING AND COMMUNITY AFFAIRS FOR THE NON-COMPETITIVE 4% HOUSING TAX CREDITS PROGRAM FOR THE REHABILITATION OF WINSTON ROSELAWN APARTMENTS, A 208-UNIT MULTI-FAMILY RENTAL HOUSING DEVELOPMENT LOCATED IN COUNCIL DISTRICT 5.**

**WHEREAS**, Winston Roselawn Apts, LP (the "Applicant") has proposed a 208-unit affordable multi-family rental housing development called Winston Roselawn Apartments (the "Development"), to be located at 2506 S. General McMullen Drive & 3346 Roselawn Road in the City of San Antonio, Texas (the "City"); and

**WHEREAS**, the Applicant will submit an application to the Texas Department of Housing and Community Affairs ("TDHCA") for the 2023 Non-Competitive 4% Housing Tax Credits for the Development (the "Application"); and

**WHEREAS**, notice of the intent to file the Application was provided to the City in accordance with Texas Government Code §2306.67071(a); and

**WHEREAS**, the City has had sufficient opportunity to obtain a response from the Applicant regarding any questions or concerns about the proposed Development; and

**WHEREAS**, it is necessary that the City hold a hearing for comments to be made on the proposed Development in accordance with Texas Government Code §2306.67071(b); and

**WHEREAS**, upon said hearing and after due consideration of the information provided by the Applicant and public comment, the City Council may adopt a resolution stating that City Council does not object to the proposed Application; **NOW THEREFORE:**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** In accordance with the requirements of Texas Government Code §2306.67071 and Texas Administrative Code §11.204(4), the City hereby certifies and finds that:

- (i) Notice of Winston Roselawn Apts, LP's ("Applicant") application to the Texas Department of Housing and Community Affairs for the Non-Competitive 4% Housing Tax Credits has been provided to the City in accordance with Texas Government Code §2306.67071(a); and

- (ii) The City Council has had sufficient opportunity to obtain a response from the Applicant regarding any questions or concerns about the proposed Development; and
- (iii) The City Council ~~Ƴ~~ has held a hearing at which public comment was invited to be made on the proposed Application in accordance with Texas Government Code, §2306.67071(b); and
- (iv) After due consideration of the information provided by the Applicant and public comment, the City Council does not object to the proposed Application.

**SECTION 2.** The City hereby confirms that it does not object to Winston Roselawn Apts, LP's application to the Texas Department of Housing and Community Affairs ("TDHCA") for the proposed Winston Roselawn Apartments (the "Development"), to be located at 2506 S. General McMullen Drive & 3346 Roselawn Road in the City of San Antonio, Texas.

**SECTION 3.** For and on behalf of the City Council, the City Clerk is hereby authorized, empowered, and directed to certify this Resolution to the TDHCA.

**SECTION 4.** This Resolution is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
