*Name other sources/brands whose products have been evaluated and why they do not meet requirements:								

Two of the Airbus EC120B's currently in fleet were purchased simultaneously in 2013 and 10-11 years is the maximum period SAPD prefers to fly these lighter frame helicopters. Airbus no longer manufactures the EC120B and the unit is seeking new replacement models. The Airbus H125 is law enforcement's most employed multipurpose helicopter and has been in production since 1975. The department's pilots and mechanics are trained on the Airbus H125. The unit identified the Bell 505 as the only other reputable light turbine helicopter capable of being outfitted for law enforcement purposes. However, the Bell 505 has only been in production for two years. As with other light helicopters, the unit is concerned the Bell 505 like the Airbus EC120B and the Schwiezer 333 will be phased out of production. If the Bell 505 is purchased, new tools will have to be purchased in order to service the new platform since tools are specific to each airframe and are not usually interchangeable. Therefore, if the Bell 505 is subsequently discontinued, the unit may have excess tools that could not be used on a new platform. The helicopters will be added to the current fleet of one Airbus H125 and replace three Airbus models EC120B, during FY2023, FY2024 and FY2026.
