**Requested Zoning:** "R-4 CD MLOD-3 MLR-2 AHOD" Residential Single-Family Martindale Military Lighting Overlay Military Lighting Region 2 Airport Hazard Overlay District with a Conditional Use for four (4) dwelling units

#### **Property Details**

**Property History:** The subject property is part of the original 36 square miles of the City of San Antonio and was originally zoned "B" Residence District. Under the 2001 Unified Development Code, established by Ordinance 93881, dated May 03, 2001, the property zoned "B" Residence District converted to the current "R-4" Residential Single-Family District.

**Topography:** The property does not include any abnormal physical features such as slope or incursion in a flood plain.

Adjacent Base Zoning and Land Uses Direction: North Current Base Zoning: "R-4" Current Land Uses: Residential Dwelling

Direction: South Current Base Zoning: "R-4" Current Land Uses: Residential Dwelling

#### **Overlay District Information:**

The "AHOD" Airport Hazard Overlay District, due to the location of the property and its proximity to an airport or approach path, does not restrict permitted uses, but can require additional review of construction plans by both the Development Services Department and the Federal Aviation Administration.

The "MLOD-3" Martindale Army Airfield Military Lighting Overlay District does not restrict permitted uses but does regulate outdoor lighting in an effort to minimize night-time light pollution and its effects on operations at the military installation.

#### **ALTERNATIVES:**

Current Zoning: "R-4" Residential Single-Family District permits single-family dwelling (detached) with a minimum lot size of 4,000 square feet and a minimum lot width of 35 feet, foster family home, public and private schools.

Proposed Zoning: "R-4" Residential Single-Family District permits single-family dwelling (detached) with a minimum lot size of 4,000 square feet and a minimum lot width of 35 feet, foster family home, public and private schools.

If approved, the "CD" Conditional Use would permit 4 residential units on the property.

FISCAL IMPACT: None.

#### PROXIMITY TO REGIONAL CENTER/PREMIUM TRANSIT CORRIDOR:

The subject property is not within a Regional Center and is also not within a <sup>1</sup>/<sub>2</sub> mile of a Premium Transit Corridor.

#### **RECOMMENDATION:**

**Staff Analysis and Recommendation:** Staff recommends Denial, with an Alternate Recommendation for "R-4 CD" Residential Single-Family District with a Conditional Use for three (3) dwelling units.

# Criteria for Review: According to Section 35-421, zoning amendments shall be based on approval criteria below.

- 1. **Consistency:** The subject property is located within the Southeast Community Area Plan and is currently designated as "Urban Low Density Residential" in the future land use component of the plan. The requested "R-4 CD" base zoning district is consistent with the future land use designation.
- 2. Adverse Impacts on Neighboring Lands: Staff does not find evidence of likely adverse impacts on neighboring lands in relation to this zoning change request. The proposed use is consistent with the established development pattern of the surrounding area. Most of the properties in the area are zoned "R-4" Residential Single-Family District.
- **3.** Suitability as Presently Zoned: The current "R-4" Residential Single-Family District is an appropriate zoning for the property and surrounding area. The proposed "R-4 CD" Residential Single-Family District with a Conditional Use for four (4) dwelling units proposes compatible residential uses, but at a density incompatible with the established development pattern. The property is at the intersection of two local streets, with alley access to the rear property line. The property is situated in an area where properties are permitted duplexes by right despite the single-family zoning, by means of the "B" to "R-4" conversion exception, and the property is sized appropriately to accommodate some additional density. Staff recommends "R-4 CD" Residential Single-Family District with a Conditional Use for three (3) dwelling units. This allows for greater density than is currently permitted, with respect to the established single-family development pattern. The "CD" Conditional use will permit the three units and require a site plan, which will address various development aspects and that will prevent expansion of the use.
- 4. Health, Safety and Welfare: Staff has not found indication of likely adverse effects on the public health, safety, or welfare.
- **5. Public Policy:** The request does not appear to conflict with any public policy objectives of the SATomorrow Southeast Community Area Plan:
  - Goal 3: Neighborhoods

o Maintain and improve the characteristics that make the neighborhoods of the Southeast Community Plan an enjoyable place to live, with special attention to walkability, open spaces, and sense of neighborhood identity.

• Goal 4: Housing

o Provide a variety of high-quality, mixed-income housing options that are wellmaintained, complementary to the character of existing neighborhoods, and accommodating to all stages of life.

- 6. Size of Tract: The subject property is 0.223 Acres, which can reasonably accommodate the proposed residential development.
- 7. Other Factors: The applicant intends to rezone to "R-4 CD" to develop four residential units on the property.

The subject property is located within the Martindale Army Airfield Awareness Zone/Military Influence Area. In accordance with the signed Memorandum of Understanding, Texas Army National Guard and JBSA were notified of the proposed request. The Military has indicated that there are no objections to this request.

The Conditional Use zoning procedure is designed to provide for a land use that is not permitted by the established zoning district, but due to individual site considerations or unique development requirements would be compatible with adjacent land uses under given conditions.

The applicant is rezoning to develop four units on the property, to be accommodated by two individual structures.

The subject property is permitted a Duplex by Section 35-D101(j) Duplexes in former 1938 "B" Zoning District. Notwithstanding any provision of this chapter to the contrary, two-family (duplex) residences are a permitted use for any tract or parcel zoned under the 1938 districts as "B" prior to the adoption date of this chapter so long as such tract is in the same configuration and so long as such tract is not the subject of rezoning in accordance with the provisions of this chapter and remains with the 2001 "R-4" zoning district. Pursuant to this subsection, two-family residences may be developed in accordance with the dimensional standards of table 310-1 and section 35-516 except as otherwise provided below:

(1) Minimum front setback of twenty (20) feet.

(2) Minimum side setback of five (5) feet.

(3) Minimum rear setback of twenty (20) percent of the lot depth or twenty (20) feet, whichever is less.

(4) Minimum lot size of six thousand (6,000) square feet.
