

Solicitation Overview



The Office of Sustainability released a solicitation to solicit a qualified solar PV provider to design, engineer, build, operate, maintain and decommission a turn-key installation of multiple rooftop and parking canopy solar photovoltaic (PV) system at the selected municipal facilities.



RFP Objectives



Advance SA Climate Ready by investing in visible, local solar projects on city facilities.


Seek market-driven responses to drive optimal project size, terms, and price with a preference for projects yielding cost savings or cost neutrality compared to expected CoSA electricity bills.

Achieve economies of scale and streamline procurement through an aggregated list of viable facilities – far more time and cost efficient than each department acting alone.

Select third-party developed projects where neither CPS Energy nor the City would be responsible for construction, operations, and maintenance of the solar projects.

Background Information – What is On-Site Solar?






On-site systems directly reduce the facility's need to purchase electricity from the grid

When the sun is not shining, the facility will buy power from CPS like it does currently

On-site solar generates clean energy to be used directly by the facility



Site Evaluation Process




- 1. Requested input from City Departments on potential sites.
- 2. Sites meet initial minimum criteria of minimum facility footprint of 15,000 ft2 or 1,400 m2 that translates to a base assumption of ~250 kw or larger per facility.
- 3. Sites evaluated by Office of Sustainability (OS) Staff and Rocky Mountain Institute (RMI) using Google's *Project Sunroof* to assess shading and NREL's *PVWatts* to estimate system sizes.
- 4. Initial evaluation of roof condition or other site constraints.
- 5. Evaluate building electrical load in order to match potential system size.
- 6. Identify potential plans for sites to avoid future disruptions.

Final Site Evaluation Results



- 42 sites across 8 City Departments
- Estimated total capacity 12.5 MW
- Total electric load offset 42%
