#### **PUBLIC COMMENTS**

• Ms. Marjesca Brown, President of the Friends of McAllister Park, shared about a plan that was presented to and approved by the Parks Board in 2018 recommending that no new development occur within undeveloped land in McAllister Park. The Friends of McAllister Park believe that the Greenway qualifies as development and are concerned with the Greenway's impact through the Mud Creek Loop. They believe that the development of the Greenway through this area would fragment and alter its natural experience and contradict with the original intent of the plan. The Friends of McAllister Park had suggested a route along the CPS easement.

  - o He thanked the LCPAB for appointing him to represent the board.

  - o Mr. Kent is looking forward to the completion of the Salado to Leon connection, as well as to the dedication event.

### Staff Report on Howard W. Peak Greenway Trails Program - Brandon Ross, Parks and Recreation

• Mr. Ross discussed the overall accomplishments of the program. 84 miles have been completed to date.

## • Projects currently under construction:

- o Leon (Rim to Eisenhower Park) 2 miles Estimated completion September 2021.
- Zarzamora Creek (General McMullen to Alderete Park) 1.5 miles Estimated completion November 2021.
- o Alazan Creek (Lombrano to Apache Confluence) 2.9 miles Estimated completion November 2021.
- o French Creek Greenway (Leon Creek Greenway to Nani Falcone Park) − 1.3 miles − Estimated completion January 2022.
- Leon Creek (Levi Strauss Park to Lackland Monument) 1.9 miles Estimated completion February 2022.
- o Salado (Southside Lions to SE Military Dr.) 3.1 miles Estimated completion April 2022.
- o Culebra Tributary (Cathedral Rock Park to Tezel Road) 1.8 miles Estimated completion fall of 2022.

#### • Recently Completed Projects:

- o Salado Trailhead at E. Commerce Street.
- o Salado Creek Wilshire Terrace Park Connection.
- o Apache Creek (19th St to Cassiano Park) 1 mile Substantially complete.
- o Apache Creek Brazos St. Connection Project Substantially complete.

#### Notable Trail Closures

- O Salado Creek Greenway The Morningstar Boardwalk is currently closed for repairs.
- Medina River Greenway The trail west of the Pleasanton Road Trailhead is currently closed due to erosion and flooding issues. It will be closed for approximately 2-3 months (reopened approximately November 2021)
