#### **SUMMARY:**

Consideration of Applicants to the Municipal Golf Association – San Antonio Board of Directors

### **BACKGROUND INFORMATION:**

The Municipal Golf Association-San Antonio (MGA-SA) Board of Directors consists of fifteen members, seven selected by MGA-SA, six appointed by the City Council, and two ex-officio voting members appointed by the City Manager. The ex-officio members are currently filled by Parks and Recreation Director, Homer Garcia III and Finance Assistant Director, Melanie Keeton. The terms of the six City Council Appointees have expired and are currently serving in holdover status. The announcement for the acceptance of applications for these positions was announced via press release on April 8, 2021. A total of twenty-seven applications were received and at the direction of the Community Health, Environment, & Culture (CHEC) Committee on August 26, 2021, an ad-hoc review committee was formed to review all applications to establish a shortlist of candidates for consideration by the full Committee.
