narrative is followed by additional background information explaining how involvement in economic and social justice issues became core to my personal mission. If I am offered the privilege of being appointed to OUR-SA, the City Council and citizens of San Antonio can count on me to tirelessly complete my due diligence for projects and to uphold the responsibilities of oversight that come with the appointment. Further, as a member of NIAC representing the Housing Commission, I observed a significant discrepancy between the anticipated proportion of deeper levels of affordability presented to the NIAC, and the proportion required in the final transaction contract. I am determined to ensure that contracts for affordable housing ensure the greatest degree of affordability for the greatest number of units possible, whether that is achieved in negotiations or the RFP, itself, or both. I will independently research and seek training on financing affordable housing projects. Finally, I will advocate for alternative development mechanisms, such as numerous models of collective and cooperative organizations. My commitment to being an active Commission or Board member comes from the fact that membership will be a continuation of my efforts with hundreds of other San Antonians to encourage the City to embrace and act upon the reality that ensuring home security among our most vulnerable residents and sustaining vibrant economic growth are synergistic, most recently reflected in my service on the Housing Commission. I recognize the significance of the Citys achieving a Council-approved housing policy framework that honestly incorporates citizens advice and that, in San Antonios history, is unique because it is a consensus of five exceptional task force members, all of whom determinedly represented widely diverse segments of residents and the business communities. I do not want to waste this rare moment and will diligently work to ensure that the guidelines are meaningfully incorporated into decisions of OURSA. My commitment to active participation also comes from my pride in San Antonio because so many with so many vantage points came together in the process that created the final Task Force report. Without Mayoral leadership, the five strategically selected MHPTF appointees, the efforts of many hundreds of citizens during the formal process and even before, City Council support, City Staff engagement, and consultant facilitation and research we would not now be implementing housing policy with such widespread buy-in. I have been active in the efforts of hundreds of citizens to help our city seek a mutually beneficial resolution of the tension between protecting home security among our most vulnerable residents and promoting the citys economic growth, most recently while serving on the Funding and Financing Technical Working Group of the Mayors Housing Policy Task Force (MHPTF). Of course, commitment and knowledgeable experience alone do not make for a good commission member. Those making appointments must be confident that members will contribute to the commissions success. I have a professional and volunteer history of working effectively among persons with differing perspectives, acting upon the belief that listening is as important as expressing ones own opinions, perhaps more so. I am driven by the democratic principle that optimal decisions arise from the broadest and most competitive marketplace of ideas. I am also fiercely protective of democratic processes, and will be vigilant that guidance emerging from transparent discussion by the board is not passively dismissed by inaction. This commitment comes from previous

experience on other commissions Additional relevant background Through a process that began about nearly 20 years ago with projects for two University of Houston Clear Lake Studies of the Future classes I became immersed in literature and current events related to livable and walkable cities and the importance of preparing citizens to compete in the global economy. But despite expanded educational and training opportunities San Antonio introduced, how could we realistically expect San Antonio residents trapped in poverty and home insecurity to take advantage of these resources In 2014, the city added insult to injury by a rezoning vote that closed a mobile home park, displaced about 300 residents from their homes, and obliterated a tightknit community through which residents provided services to one another that counterbalanced the challenges of their lives It was that catastrophic event that illustrated the forces and policies (or lack of them) in our city that enabled city and business processes to steal even the most modest of homes from 300 persons, including elderly and sick residents, as well as children, without ensuring resources to adequately compensate them for even the tangible costs of relocating.
