## **ORDINANCE**

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The bid submitted by Red McCombs Ford to provide the Animal Care Services Department with six live animal transport trucks for a total cost of \$389,160.00 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation is attached hereto and incorporated herein for all purposes as **Exhibit I**.

**SECTION 2.** Funding for this ordinance in the amount of \$259,440.00 is available in Fund 72001000, Cost Center 3503200001 and General Ledger 5709080 as part of the Fiscal Year 2022 Adopted Budget approved by City Council.

**SECTION 3.** Funding for this ordinance in the amount of \$129,720.00 is available in Fund 11001000, Cost Center 3702010001 and General Ledger 5709080 as part of the Fiscal Year 2022 Adopted Budget approved by City Council.

**SECTION 4.** Payment is authorized to Red McCombs Ford and should be encumbered with a purchase order.
