ORDINANCE

APPROVING A SPORTS LICENSE AGREEMENT WITH TOWNE & COUNTRY OPTIMIST LITTLE LEAGUE, INC. FOR OPERATIONS, MAINTENANCE, AND PROGRAMMING OF A DESIGNATED SPORTS FIELD AT OLMOS BASIN PARK IN COUNCIL DISTRICT 3.

WHEREAS, Towne & Country Optimist Little League, Inc. has been a licensee of sports fields located at Olmos Basin Park since 1970; and

WHEREAS, The League provides organized youth sports and serves over 85 area youth each year; and

WHEREAS, On February 1, 2017, the City and Towne & Country Optimist Little League, Inc. entered into a Sports License Agreement for the operations, maintenance, and programming of sports fields at Olmos Basin Park in Council District 1; and

WHEREAS, The current agreement will expire on January 31, 2022, and a new Sports License Agreement is proposed to commence on February 1, 2022 and expire on December 31, 2027; and

WHEREAS, in lieu of rent, the league shall be responsible for operations and maintenance of the designated sports field; and

WHEREAS, in addition, the league will be permitted to operate concessions with proceeds benefiting their program and used to offset the cost of operations and maintenance; and

WHEREAS, the Small Business Economic Development Advocacy ordinance requirements were waived due to the lack of small, minority, and/or women businesses available to provide these goods and services; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee, or the Director of the Parks and Recreation Department or designee, is hereby authorized to execute a Sports License Agreement with Pop Warner Southside Little Cowboys for operations, maintenance and programming of a designated sports field at Stinson Park for a five (5) year term. A copy of the License Agreement in substantially final form is attached hereto and incorporated herein for all purposes as **Attachment I**.

SECTION 4. This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
