## ORDINANCE

## APPROVING THE PARKS AND RECREATION DEPARTMENT TO EXECUTE A SPORTS LICENSE AGREEMENT WITH PROSPECT HILL YELLOW JACKETS ATHLETIC CLUB FOR OPERATIONS, MAINTENANCE, AND PROGRAMMING OF DESIGNATED SPORTS FIELDS AT ROSEDALE PARK IN COUNCIL DISTRICT 5. THERE IS NO FISCAL IMPACT ASSOCIATED WITH THIS ORDINANCE.

**WHEREAS**, Prospect Hill Yellow Jackets Athletic Club has utilized sports fields at Rosedale Park for organized youth sports programming since 1981 and provides organized youth sports and serves over 1,000 area youth each year; and

**WHEREAS**, on January 4, 2017, the City and Prospect Hill Yellow Jackets Athletic Club entered into a Sports License Agreement for the operations, maintenance, and programming of three sports fields and a concession building at Rosedale Park in Council District 5; and

WHEREAS, the current agreement will expire on January 3, 2022 and a new Sports License Agreement is proposed to commence on January 1, 2022 and expire on December 31, 2027; and

**WHEREAS**, the league shall be responsible for operations and maintenance of the designated sports fields and the league will be permitted to operate concessions with proceeds benefitting their program and to offset the cost of operations and maintenance; and

**WHEREAS**, the Small Business Economic Development Advocacy ordinance requirements were waived due to the lack of small, minority, and/or women businesses available to provide these goods and services; and

**WHEREAS**, this action is consistent with the adopted SA Parks System Plan by leveraging community partnerships to expand recreational opportunities in the community in order to address these concerns, several strategies in the final system plan were enhanced to advance these efforts

WHEREAS, this ordinance authorizes the Parks and Recreation Department to execute a Sports License Agreement with Prospect Hill Yellow Jackets Athletic Club for operations, maintenance, and programming of designated sports fields at Rosedale Park in Council District 5; NOW THEREFORE:

**SECTION 1.** The City Manager, or designee, or the Director of Parks and Recreation Department or designee, is hereby authorized to execute a Sports License Agreement with Prospect Hill Yellow Jackets Athletic Club for operations, maintenance, and programming of designated sports fields at Rosedale Park in Council District 5

SECTION 2. This ordinance will have no fiscal impact on the City's operations.

**SECTION 3.** No fiscal ordinance language required.

**SECTION 4.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
